A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to awarding certain medals for military service performed
- 3 individually or as part of a crew.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 437.352, Government Code, is amended to
- 6 read as follows:
- 7 Sec. 437.352. LONE STAR MEDAL OF VALOR. The Lone Star Medal
- 8 of Valor shall be awarded to a member of the military forces of this
- 9 state, another state, or the United States who performs, either
- 10 <u>individually or as a member of a crew</u>, specific acts of bravery or
- 11 outstanding courage, or who performs within an exceptionally short
- 12 period, either individually or as a member of a crew, a closely
- 13 related series of heroic acts, if the acts involve personal hazard
- 14 or danger and the voluntary risk of life and result in an
- 15 accomplishment so exceptional and outstanding as to clearly set the
- 16 person or crew apart from the person's or crew's comrades or from
- 17 other persons in similar circumstances. Awarding of the medal
- 18 requires a lesser degree of gallantry than awarding of the Texas
- 19 Legislative Medal of Honor, but requires that the acts be performed
- 20 with marked distinction.
- 21 SECTION 2. Section 437.355(a), Government Code, is amended
- 22 to read as follows:
- 23 (a) The governor or adjutant general, if delegated the
- 24 authority, may adopt policies and regulations relating to awarding:

- 1 (1) the Texas Purple Heart Medal, which shall be
- 2 awarded to a service member who:
- 3 (A) after September 11, 2001:
- 4 (i) was inducted into federal service from
- 5 the Texas National Guard; and
- 6 (ii) meets the criteria for an award of the
- 7 federal Purple Heart Medal; or
- 8 (B) was wounded or killed at Fort Hood on
- 9 November 5, 2009;
- 10 (2) the Texas Superior Service Medal, which shall be
- 11 awarded to:
- 12 (A) a service member of the Texas military forces
- 13 who has:
- 14 (i) completed 30 or more years of honorable
- 15 state service or a combination of state and federal service; and
- 16 (ii) continually demonstrated superior
- 17 performance and service while assigned to key leadership positions
- 18 demanding responsibility; or
- 19 (B) a civilian who has contributed significant
- 20 service to the Texas military forces;
- 21 (3) the Lone Star Distinguished Service Medal, which
- 22 shall be awarded to a member of the military forces of this state,
- 23 another state, or the United States for exceptionally outstanding
- 24 achievement or service to this state in performance of a duty of
- 25 great responsibility while serving with the Texas military forces
- 26 for whom the department receives a letter of recommendation for
- 27 award of the Lone Star Distinguished Service Medal that:

- 1 (A) gives an account of the exceptional
- 2 achievement or service; and
- 3 (B) includes facts and photographs, and extracts
- 4 from official documents to support and amplify the facts;
- 5 (4) the Texas Outstanding Service Medal, which shall
- 6 be awarded to a service member of the military forces of this state,
- 7 another state, or the United States who has performed service,
- 8 either individually or as a member of a crew, in a superior and
- 9 clearly outstanding manner;
- 10 (5) the Texas Humanitarian Service Medal, which shall
- 11 be awarded to a service member who:
- 12 (A) does not meet the criteria for an award of the
- 13 federal Humanitarian Service Medal;
- 14 (B) is a member of the Texas military forces; and
- 15 (C) while serving on state active duty or active
- 16 duty under state authority in accordance with Title 32, United
- 17 States Code, participates satisfactorily in defense support to a
- 18 mission under civilian authority to protect life or property during
- 19 or soon after a natural disaster or civil unrest in the state;
- 20 (6) the Texas Homeland Defense Service Medal, which
- 21 shall be awarded to a service member of the Texas military forces
- 22 who served:
- 23 (A) on or after September 11, 2001;
- 24 (B) on state active duty or active duty under
- 25 state authority in accordance with Title 32, United States Code;
- 26 and
- (C) satisfactorily in defense support to a

- 1 mission in the state under civilian authority;
- 2 (7) the Federal Service Medal, which shall be awarded
- 3 to a service member who was inducted into federal service from the
- 4 Texas military forces between June 15, 1940, and January 1, 1946, or
- 5 after June 1, 1950, if the service was for more than 90 days;
- 6 (8) the Texas Combat Service Ribbon, which shall be
- 7 awarded to a service member of the Texas National Guard who served,
- 8 after September 11, 2001, in a hostile fire zone as designated by
- 9 the United States secretary of defense;
- 10 (9) the Texas Faithful Service Medal, which shall be
- 11 awarded to a member of the Texas military forces who has completed
- 12 five years of honorable service during which the service member has
- 13 shown fidelity to duty, efficient service, and great loyalty to
- 14 this state;
- 15 (10) the Texas Medal of Merit, which shall be awarded
- 16 to a member of the military forces of this state, another state, or
- 17 the United States who performs outstanding service or attains
- 18 extraordinary achievement, either individually or as a member of a
- 19 crew, in behalf of the state or United States;
- 20 (11) the Texas State Guard Service Medal, which shall
- 21 be awarded to a service member who completes three consecutive
- 22 years of honorable service in the Texas State Guard during which the
- 23 service member has shown fidelity to duty, efficient service, and
- 24 great loyalty to this state;
- 25 (12) the Texas Desert Shield/Desert Storm Campaign
- 26 Medal, which shall be awarded to a service member who was inducted
- 27 into federal service from the Texas National Guard after August 1,

- 1 1990, in support of Operation Desert Shield or Operation Desert
- 2 Storm, without regard to the place that the service member was
- 3 deployed while serving on active federal military duty;
- 4 (13) the Texas Iraqi Campaign Medal, which shall be
- 5 awarded to a service member who was inducted into federal service
- 6 from the Texas National Guard, without regard to the place that the
- 7 service member was deployed while serving on active federal
- 8 military duty, after:
- 9 (A) March 19, 2003, in support of Operation Iraqi
- 10 Freedom; or
- 11 (B) August 31, 2010, in support of Operation New
- 12 Dawn;
- 13 (14) the Texas Afghanistan Campaign Medal, which shall
- 14 be awarded to a service member who was inducted into federal service
- 15 from the Texas National Guard after October 6, 2001, in support of
- 16 Operation Enduring Freedom, without regard to the place that the
- 17 service member was deployed while serving on active federal
- 18 military duty; and
- 19 (15) the Cold War Medal, which, subject to Subsection
- 20 (c), shall be awarded to a member of the military forces of this
- 21 state or the United States who:
- (A) served between September 2, 1945, and
- 23 December 26, 1991; and
- (B) was a resident of this state at the time the
- 25 service member entered military service.
- SECTION 3. This Act takes effect September 1, 2019.
