17 (a) A member [or group of members] of a governmental body

1 (2) knew at the time the member engaged in the 2 communication that the series of communications: 3 (A) involved or would involve a quorum; and 4 (B) would constitute a deliberation once a quorum 5 of members engaged in the series of communications [conspires to 6 circumvent this chapter by meeting in numbers less than a quorum for 7 the purpose of secret deliberations in violation of this chapter].

SECTION 4. Section 551.143, Government Code, as amended by 8 this Act, applies only to an offense committed on or after the 9 effective date of this Act. An offense committed before the 10 effective date of this Act is governed by the law in effect on the 11 date the offense was committed, and the former law is continued in 12 effect for that purpose. For purposes of this section, an offense 13 was committed before the effective date of this Act if any element 14 15 of the offense occurred before that date.

16 SECTION 5. This Act takes effect immediately if it receives 17 a vote of two-thirds of all the members elected to each house, as 18 provided by Section 39, Article III, Texas Constitution. If this 19 Act does not receive the vote necessary for immediate effect, this 20 Act takes effect September 1, 2019.
