17	services employees on identifying and interacting with individuals

19	an initial four-hour training requirement and an annual two-hour

conjunction with that training. The training program must cover,

- 3 SECTION 2. As soon as practicable after the effective date
- 4 of this Act, the Department of Family and Protective Services
- 5 shall:
- 6 (1) develop or approve the Alzheimer's disease and
- 7 dementia training program required by Section 40.036, Human
- 8 Resources Code, as added by this Act; and
- 9 (2) begin providing the initial training required by
- 10 that section to all existing and newly hired adult protective
- 11 services employees, as defined by that section.
- 12 SECTION 3. This Act takes effect September 1, 2019.
