## A BILL TO BE ENTITLED

Τ	AN ACT
2	relating to the issuance or renewal of a license to carry a handgun.
3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Sections 411.177(a) and (b), Government Code,
5	are amended to read as follows:
6	(a) The department $\underline{may}$ [ $\underline{shall}$ ] issue a license to carry a
7	handgun to an applicant if the applicant meets all the eligibility
8	requirements and submits all the application materials. The
9	department shall administer the licensing procedures in good faith
10	and [so that any applicant who meets all the eligibility
11	requirements and submits all the application materials shall
12	receive a license. The department   may not deny an application on
13	the basis of a capricious or arbitrary decision by the department.
14	A denial must be supported by a preponderance of the evidence.
15	(b) The department shall, not later than the 60th day after
16	the date of the receipt by the director's designee of the completed
17	application materials:
18	(1) issue the license;
19	(2) notify the applicant in writing that the
20	application was denied and explain the grounds for the denial $[+$
21	[(A) on the grounds that the applicant failed to
22	qualify under the criteria listed in Section 411.172;
23	[(B) based on the affidavit of the director's
24	designee submitted to the department under Section 411.176(c); or

- 1 [(C) based on the affidavit of the qualified
- 2 handgun instructor submitted to the department under Section
- $3 \frac{411.188(k)}{(k)}$ ; or
- 4 (3) notify the applicant in writing that the
- 5 department is unable to make a determination regarding the issuance
- 6 or denial of a license to the applicant within the 60-day period
- 7 prescribed by this subsection and include in that notification an
- 8 explanation of the reason for the inability and an estimation of the
- 9 amount of time the department will need to make the determination.
- SECTION 2. Section 411.185(e), Government Code, is amended
- 11 to read as follows:
- (e) The department may [shall] renew the license of a
- 13 license holder who meets all the eligibility requirements to
- 14 continue to hold a license and submits all the renewal materials
- 15 described by Subsection (a). Not later than the 45th day after
- 16 receipt of the renewal materials, the department shall issue the
- 17 renewed license or notify the license holder in writing that the
- 18 department denied the license holder's renewal application. A
- 19 denial must be supported by a preponderance of the evidence.
- 20 SECTION 3. The change in law made by this Act applies only
- 21 to an applicant for an original or renewed license to carry a
- 22 handgun under Subchapter H, Chapter 411, Government Code, as
- 23 amended by this Act, who submits the application on or after the
- 24 effective date of this Act.
- 25 SECTION 4. This Act takes effect September 1, 2019.
