13	establish a family violence pretrial diversion pilot program for
14	individuals who are charged with an offense involving family
15	violence and who suffer from a substance abuse disorder or chemical
16	dependency.
17	(c) The pretrial diversion pilot program developed under

No. 3529 1 procedure to rapidly respond to pilot program participants who fail 2 to comply with pilot program requirements, including, when 3 appropriate, immediate removal from the pilot program; and 4 (4) the use of a video teleconferencing system in 5 court to facilitate the cooperation of witnesses in the criminal justice system and to reduce costs associated with transporting 6 defendants. 7 (d) The department shall review the pilot program 8 established under this section and submit a report to the governor, 9 10 the lieutenant governor, the speaker of the house of representatives, and the legislature not later than December 1 of 11 each even-numbered year. The report must include: 12 (1) a summary of the status and results of the pilot 13 14 program; 15 (2) an analysis of the effectiveness of the pilot program in reducing the rate of family violence recidivism among 16 17 individuals charged with an offense involving family violence and suffering from a substance abuse disorder or chemical dependency; 18 19 (3) sources of funding available to extend the pilot program to other counties or for a longer period of time, including 20 available local, state, and federal funding sources; and 21 (4) any legislative or other recommendations. 22 (e) This section expires September 1, 2023. 23 24 SECTION 2. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as 25 provided by Section 39, Article III, Texas Constitution. If this 26 Act does not receive the vote necessary for immediate effect, this 27
