- 9 Sec. 580.001. DEFINITIONS. In this chapter:
- (1) "Commission" means the Health and Human Services 10

- Sec. 580.002. MENTAL HEALTH TREATMENT FOR INCARCERATION 14
- DIVERSION PILOT PROGRAM. The commission, in cooperation with the 15
- commissioners court, shall establish a pilot program in Fort Bend 16
- County to be implemented by the commissioners court for the purpose 17
- of reducing recidivism and the frequency of arrests and 18
- incarceration of persons with mental illness in that county. 19
- Sec. 580.003. CRIMINAL JUSTICE MENTAL HEALTH SERVICE MODEL. 20
- The commissioners court shall design and test through the pilot 21
- program a criminal justice mental health service model oriented 22
- 23 toward facilitating treatment for persons with mental illness to
- reduce the recidivism and frequency of arrests and incarceration of 24

13	Sec. 580.006. PROGRAM CAPACITY. (a) In implementing the	
14	pilot program, the commissioners court shall ensure the program has	
15	the resources to provide mental health treatment for incarceration	
16	diversion services to not fewer than 10 individuals.	
17	(b) The commissioners court shall endeavor to serve each	
18	year the pilot program operates not fewer than 10 or more than 20	
19	individuals cumulatively.	
20	(c) Before the commissioners court implements the pilot	
21	program, the commission and the commissioners court jointly shall	
22	establish clear criteria for identifying a target population to be	
23	served by the program. The criteria must prioritize serving a	
24	target population composed of members at high risk of recidivism	
25	and with severe mental illness. The commissioners court, in	
26	consultation with the appropriate entities listed in Section	
27	580.005, may adjust the criteria established under this subsection	

- 1 during the operation of the program provided the adjusted criteria
- 2 are clearly articulated.
- 3 Sec. 580.007. FINANCING THE PROGRAM. (a) The creation of
- 4 the pilot program under this chapter is contingent on the
- 5 continuing agreement of the commissioners court to contribute to
- 6 the program each year in which the program operates services for
- 7 persons with mental illness equivalent in value to funding provided
- 8 by the state for the program.
- 9 (b) It is the intent of the legislature that appropriations
- 10 made to fund the pilot program are made in addition to and will not
- 11 reduce the amount of appropriations made in the regular funding of
- 12 the local mental health authority for Fort Bend County.
- 13 (c) The commissioners court may seek and receive gifts and
- 14 grants from federal sources, foundations, individuals, and other
- 15 sources for the benefit of the pilot program.
- Sec. 580.008. INSPECTIONS. The commission may make
- 17 inspections of the operation of and provision of mental health
- 18 treatment for incarceration diversion services through the pilot
- 19 program on behalf of the state to ensure state funds appropriated
- 20 for the program are used effectively.
- Sec. 580.009. REPORT. (a) Not later than December 1, 2020,
- 22 the executive commissioner shall evaluate and submit a report
- 23 concerning the effect of the pilot program in reducing recidivism
- 24 and the frequency of arrests and incarceration of persons with
- 25 mental illness in Fort Bend County to the governor, the lieutenant
- 26 governor, the speaker of the house of representatives, and the
- 27 presiding officers of the standing committees of the senate and

- 1 house of representatives having primary jurisdiction over health
- 2 and human services issues and over criminal justice issues.
- 3 (b) The report must include a description of the features of
- 4 the criminal justice mental health service model designed and
- 5 tested under the pilot program and the executive commissioner's
- 6 recommendation whether to expand use of the model statewide.
- 7 (c) In conducting the evaluation required under Subsection
- 8 (a), the executive commissioner shall compare the rate of
- 9 recidivism in Fort Bend County among persons in the target
- 10 population before the date the pilot program is implemented in the
- 11 community to the rate of recidivism among those persons two years
- 12 after the date the program is implemented in the community and three
- 13 years after the date the program is implemented in the community.
- 14 The executive commissioner may include in the evaluation measures
- 15 of the effectiveness of the program related to the well-being of
- 16 persons served under the program.
- 17 Sec. 580.010. CONCLUSION; EXPIRATION. The pilot program
- 18 established under this chapter concludes and this chapter expires
- 19 September 1, 2021.
- 20 SECTION 2. This Act takes effect immediately if it receives
- 21 a vote of two-thirds of all the members elected to each house, as
- 22 provided by Section 39, Article III, Texas Constitution. If this
- 23 Act does not receive the vote necessary for immediate effect, this
- 24 Act takes effect September 1, 2019.
