- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 615.022, Government Code, is amended to
- 7 read as follows:
- 8 Sec. 615.022. PAYMENT TO SURVIVORS. (a) If there is an
- 9 eligible surviving spouse, the state shall pay the benefits
- 10 described by Subsection (d) [\$500,000] to the eligible surviving
- 11 spouse.
- 12 (b) If there is no eligible surviving spouse, the state
- 13 shall pay the benefits described by Subsection (d) [\$500,000] in
- 14 equal shares to surviving children.
- 15 (c) If there is no eligible surviving spouse or child, the
- 16 state shall pay the benefits described by Subsection (d) [\$500,000]
- 17 in equal shares to surviving parents.
- 18 <u>(d) An eligible survivor, or eligible survivors in equal</u>
- 19 shares, are entitled to receive a lump sum payment in the amount
- 20 provided by this subsection. The lump sum payment amount payable to
- 21 an eligible survivor during the 12 months beginning September 1,
- 22 2019, is \$500,000. Effective September 1 of each following year,
- 23 the board of trustees of the Employees Retirement System of Texas by
- 24 rule shall adjust the amount of the lump sum payment required under

- 1 this subsection by an amount equal to the percentage change in the
- 2 Consumer Price Index for All Urban Consumers, published by the
- 3 Bureau of Labor Statistics of the United States Department of Labor
- 4 for the preceding year. The amount paid to an eligible survivor or
- 5 survivors as adjusted under this subsection is calculated based on
- 6 the date of the decedent's death and not on the date the eligible
- 7 <u>survivor or survivors file a claim under this chapter.</u>
- 8 SECTION 2. The changes in law made by this Act apply to a
- 9 payment of assistance to survivors of certain public employees on
- 10 or after the effective date of this Act regardless of the date the
- 11 public employee died.
- 12 SECTION 3. This Act takes effect September 1, 2019.
