- 14 $\underline{\text{(3-b)}}$ "Project costs" has the meaning assigned by 15 Section 311.002(1), Tax Code.
- SECTION 2. Section 373A.003(a), Local Government Code, is amended to read as follows:
- 18 (a) This chapter applies to:
- $\underline{\text{(1)}}$ a municipality with a population of more than
- 20 750,000 that is located in a uniform state service region with fewer
- 21 than 550,000 occupied housing units as determined by the most
- 22 recent United States decennial census; and
- 23 (2) a municipality with a population of two million or
- 24 more.

- 1 SECTION 3. Section 373A.052, Local Government Code, is
- 2 amended by amending Subsection (a) and adding Subsection (a-1) to
- 3 read as follows:
- 4 (a) To be designated as a district within a municipality
- 5 described by Section 373A.003(a)(1) [$\frac{373A.003(a)}{a}$] under this
- 6 subchapter, an area must be composed of census tracts forming a
- 7 spatially compact area with:
- 8 (1) fewer than 75,000 residents;
- 9 (2) an overall poverty rate that is at least two times
- 10 the poverty rate for the entire municipality; and
- 11 (3) in each census tract within the area, a median
- 12 family income that is less than 80 percent of the median family
- 13 income for the entire municipality.
- 14 (a-1) To be designated as a district within a municipality
- described by Section 373A.003(a)(2) under this subchapter:
- 16 (1) an area must be composed of census tracts forming a
- 17 spatially compact area; and
- 18 (2) the governing body of the municipality must make
- 19 findings by resolution that:
- 20 (A) the area will benefit from the inclusion of
- 21 low income households;
- 22 (B) low-income and moderate-income homeowners
- 23 within the area are at risk of losing their homesteads through
- 24 displacement; and
- (C) the designation will serve one or more
- 26 purposes outlined by this chapter.
