2 SECTION 5. Section 43.007(a), Election Code, is amended to 3 read as follows:

4 (a) The secretary of state shall implement a program to 5 allow each commissioners court participating in the program to 6 eliminate county election precinct polling places and establish 7 countywide polling places for:

8 (1) each general election for state and county9 officers;

10 (2) [each election held on the uniform election date 11 in May and any resulting runoff;

2 (b) Unless a district holds its general election for 3 officers on a date as otherwise provided by statute, after 4 confirmation of a district, an election shall be held on the uniform 5 election date, provided by Section 41.001, Election Code, [in May 6 of each even-numbered year] to elect the appropriate number of 7 directors.

8 SECTION 7. Section 56.804(a), Water Code, is amended to 9 read as follows:

10 (a) The election shall be held on the [a] uniform election

SECTION 9. This Act applies only to an election ordered on or after the effective date of this Act. An election ordered before the effective date of this Act is governed by the law as it existed immediately before the effective date of this Act, and that law is continued in effect for that purpose.
