5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle C, Title 5, Business & Commerce Code, is
7	amended by adding Chapter 114 to read as follows:
8	CHAPTER 114. PROVIDERS AND TRAINERS OF ASSISTANCE ANIMALS FOR
9	<u>VETERANS</u>
10	Sec. 114.001. DEFINITIONS. In this chapter:
11	(1) "Assistance animal" means a canine that is
12	specially trained or equipped to help a veteran diagnosed with
13	post-traumatic stress disorder and that is used by a veteran with
14	<pre>post-traumatic stress disorder.</pre>
15	(2) "Veteran" has the meaning assigned by Section
16	53.001, Human Resources Code.
17	Sec. 114.002. REQUIREMENTS FOR PROVIDERS OR TRAINERS OF
18	ASSISTANCE ANIMALS FOR VETERANS. An individual or business entity
19	that provides, by sale or donation, or trains assistance animals
20	shall:
21	(1) provide an average of 30 or more hours of
22	one-on-one training over a 90-day or longer period to each
23	assistance animal provided or trained by the individual or entity;
24	(2) obtain a wellness verification from a licensed

- 1 veterinarian during the period described by Subdivision (1) for
- 2 each assistance animal provided or trained by the individual or
- 3 entity;
- 4 (3) work with each veteran using an assistance animal
- 5 provided or trained by the individual or entity for 10 or more days
- 6 and provide the veteran at least 30 hours of training with the
- 7 <u>assistance animal;</u>
- 8 (4) ensure that each assistance animal provided or
- 9 <u>trained by the individual or entity has passed:</u>
- 10 (A) the American Kennel Club Canine Good Citizen
- 11 test, or a test having standards substantially similar to the
- 12 standards of the American Kennel Club Canine Good Citizen test in
- 13 effect on September 1, 2019; and
- 14 (B) the Assistance Dogs International Public
- 15 Access Test, or a test having standards substantially similar to
- 16 the standards of the Assistance Dogs International Public Access
- 17 Test in effect on September 1, 2019; and
- 18 <u>(5) make available follow-up services to each veteran</u>
- 19 using an assistance animal provided or trained by the individual or
- 20 entity for the life of the assistance animal.
- Sec. 114.003. CIVIL PENALTY; INJUNCTION. (a) An
- 22 <u>individual or business entity that violates a provision of this</u>
- 23 chapter is liable to the state for a civil penalty in an amount not
- 24 to exceed \$500 for each separate violation and, in the case of a
- 25 continuing violation, an amount not to exceed \$500 for each
- 26 subsequent day on which the violation occurs.
- 27 (b) The attorney general or an appropriate prosecuting

- 1 attorney may sue to collect a civil penalty under this section.
- 2 (c) The attorney general may bring an action in the name of
- 3 the state to restrain or enjoin a violation or threatened violation
- 4 of this chapter.
- 5 Sec. 114.004. CIVIL LIABILITY. (a) A business entity that
- 6 sells an assistance animal to a person in violation of this chapter
- 7 <u>is liable to the person for the amount the person paid for the</u>
- 8 assistance animal.
- 9 (b) A person who prevails in an action brought under this
- 10 <u>section</u> is also entitled to recover court costs and reasonable
- 11 attorney's fees.
- 12 SECTION 2. This Act takes effect September 1, 2019.
