C.S.H.B. No. 3890

A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the exemption of tuition and laboratory fees at public
- 3 institutions of higher education for certain paramedics.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. The heading to Section 54.353, Education Code,
- 6 is amended to read as follows:
- 7 Sec. 54.353. FIREFIGHTERS OR PARAMEDICS ENROLLED IN FIRE
- 8 SCIENCE COURSES.
- 9 SECTION 2. Section 54.353, Education Code, is amended by
- 10 amending Subsections (a) and (f) and adding Subsection (e-1) to
- 11 read as follows:
- 12 (a) The governing board of an institution of higher
- 13 education shall exempt from the payment of tuition and laboratory
- 14 fees any student enrolled in one or more courses offered as part of
- 15 a fire science curriculum who:
- 16 (1) is employed as a firefighter or a paramedic by a
- 17 political subdivision of this state; or
- 18 (2) is currently, and has been for at least one year,
- 19 an active member of an organized volunteer fire department
- 20 participating in the Texas Emergency Services Retirement System or
- 21 a retirement system established under the Texas Local Fire Fighters
- 22 Retirement Act (Article 6243e, Vernon's Texas Civil Statutes) and
- 23 who holds:
- 24 (A) an Accredited Advanced level of

- 1 certification, or an equivalent successor certification, under the
- 2 State Firemen's and Fire Marshals' Association of Texas volunteer
- 3 certification program; or
- 4 (B) Phase V (Firefighter II) certification, or an
- 5 equivalent successor certification, under the Texas Commission on
- 6 Fire Protection's voluntary certification program under Section
- 7 419.071, Government Code.
- 8 (e-1) Notwithstanding Subsection (a), the governing board
- 9 of an institution of higher education may, in accordance with Texas
- 10 <u>Higher Education Coordinating Board rule</u>, exclude from the
- 11 exemption under this section a course that is offered through
- 12 distance education.
- 13 (f) The Texas Higher Education Coordinating Board shall
- 14 adopt:
- 15 (1) rules governing the granting or denial of an
- 16 exemption under this section, including rules:
- 17 (A) prescribing the educational attainment or
- 18 level of certification necessary to qualify for an exemption as a
- 19 paramedic;
- 20 <u>(B)</u> relating to the determination of a student's
- 21 eligibility for an exemption; and
- (C) relating to the exclusion from the exemption
- 23 under Subsection (e-1) of a distance education course, including
- 24 prescribing the maximum number of distance education courses that
- 25 may be excluded from the exemption under that subsection; and
- 26 (2) a uniform listing of degree programs covered by
- 27 the exemption under this section.

- 1 SECTION 3. (a) The Texas Higher Education Coordinating
- 2 Board shall adopt the rules required by Section 54.353(f),
- 3 Education Code, as amended by this Act, as soon as practicable after
- 4 the effective date of this Act.
- 5 (b) Section 54.353, Education Code, as amended by this Act,
- 6 applies beginning with tuition and laboratory fees charged for the
- 7 2019 fall semester. Tuition and laboratory fees charged for an
- 8 academic period before that semester are covered by the law in
 - effect immediately before the effective date of this Act, and the
- 10 former law is continued in effect for that purpose.
- 11 SECTION 4. This Act takes effect immediately if it receives
- 12 a vote of two-thirds of all the members elected to each house, as
- 13 provided by Section 39, Article III, Texas Constitution. If this
- 14 Act does not receive the vote necessary for immediate effect, this
- 15 Act takes effect September 1, 2019.
