## A BILL TO BE ENTITLED

⊥	AN ACT	

- 2 relating to the creation of a study of TRS-ActiveCare administered
- 3 by the Teacher Retirement System of Texas.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. COMMITTEE. (a) A committee is created to study
- 6 and review TRS-ActiveCare, administered under Chapter 1579,
- 7 Insurance Code, and propose reforms to address issues described by
- 8 Section 2 of this Act.
- 9 (b) The committee is composed of the following members:
- 10 (1) two persons appointed by the governor;
- 11 (2) two persons appointed by the lieutenant governor;
- 12 (3) two persons appointed by the speaker of the house
- 13 of representatives; and
- 14 (4) two persons employed by the Teacher Retirement
- 15 System of Texas and appointed by the board of trustees of the
- 16 system.
- 17 SECTION 2. STUDY REGARDING CERTAIN HEALTH BENEFIT PLANS.
- 18 The committee created by Section 1 of this Act shall study
- 19 TRS-ActiveCare to examine and assess the following issues:
- 20 (1) the financial soundness of the plans offered under
- 21 TRS-ActiveCare;
- 22 (2) the cost and affordability of plan coverage to
- 23 persons eligible for coverage under the plans;
- 24 (3) the sufficiency of access to physicians and health

- 1 care providers under the plans; and
- 2 (4) alternative mechanisms for offering health
- 3 benefit plan coverage to the affected employees and the affected
- 4 employees' dependents.
- 5 SECTION 3. COMMITTEE FINDINGS AND RECOMMENDATIONS. (a)
- 6 Not later than January 15, 2021, the committee appointed under this
- 7 Act shall report the committee's findings and recommendations to
- 8 the lieutenant governor, the speaker of the house of
- 9 representatives, and the governor. The committee shall include in
- 10 its recommendations specific statutory and regulatory changes that
- 11 appear beneficial from the results of the committee's study under
- 12 Section 2 of this Act.
- 13 (b) Not later than the 60th day after the effective date of
- 14 this Act, the governor, lieutenant governor, speaker of the house
- 15 of representatives, and board of trustees of the Teacher Retirement
- 16 System of Texas shall appoint the members of the committee created
- 17 under Section 1 of this Act in accordance with that section.
- 18 SECTION 4. ABOLITION OF COMMITTEE. The committee created
- 19 by this Act is abolished and this Act expires January 20, 2021.
- 20 SECTION 5. EFFECTIVE DATE. This Act takes effect
- 21 immediately if it receives a vote of two-thirds of all the members
- 22 elected to each house, as provided by Section 39, Article III, Texas
- 23 Constitution. If this Act does not receive the vote necessary for
- 24 immediate effect, this Act takes effect September 1, 2019.
