5	SECTION 1. Section 51.9685, Education Code, is amended by
6	adding Subsection (c-2) and amending Subsection (g) to read as
7	follows:
8	(c-2) A student enrolled in a course for joint high school
9	and junior college credit under Section 130.008 at a public junior
10	college and to whom Subsection (b) or (c-1) does not apply shall
11	file a degree plan with the college not later than:
12	(1) the end of the second regular semester or term
13	immediately following the semester or term in which the student
14	earned a cumulative total of 15 or more semester credit hours of
15	course credit for dual credit courses successfully completed by the
16	student; or
17	(2) if the student begins the student's first semester
18	or term at the college with 15 or more semester credit hours of
19	course credit for dual credit courses successfully completed by the
20	student, the end of the student's second regular semester or term at
21	the college.
22	(g) The Texas Higher Education Coordinating Board, in
23	consultation with institutions of higher education, <u>shall</u> [may]
24	adopt rules as necessary for the administration of this section <u>,</u>

including rules requiring institutions of higher education to 1 report to the board information regarding the filing of degree 2 3 plans as required by this section. 4 SECTION 2. Section 130.0104(c), Education Code, is amended 5 to read as follows: 6 (c) In complying with the requirements regarding the filing 7 of a degree plan under [Notwithstanding] Section 51.9685, [before the beginning of the regular semester or term immediately following 8 the semester or term in which] a student enrolled [successfully 9 completes a cumulative total of 30 or more semester credit hours for 10 coursework] in a multidisciplinary studies associate degree 11 program established under this section [, the student] must meet 12 with an academic advisor to complete a degree plan [, as defined by 13 Section 51.9685(a)(1), that: 14 15 (1) accounts for all remaining credit hours required for the completion of the degree program; and 16 17 (2) emphasizes: (A) the student's transition to a particular 18 four-year college or university that the student chooses; and 19 20 preparations for the student's intended (B) field of study or major at the four-year college or university. 21 22 SECTION 3. This Act applies beginning with the 2019-2020 23 academic year. 24 SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as 25 provided by Section 39, Article III, Texas Constitution. If this 26
