Section 51.3041(b), Education Code, is amended to read as follows: 7 (b) An institution of higher education shall consider, in 8 determining whether to award to a student course credit toward a 9 degree or certificate offered by the institution for the student's 10 11 completion of certain military training: 12 (1) any official military record presented to the 13 institution by the student that: 14 (A) describes the substance of the training completed by the student; and 15 (B) verifies the student's successful completion 16 of that training; and 17 (2) whether the substance of that training satisfies 18 the purpose of the course for which the student seeks credit as 19 20 described in the institution's course catalog. 21 SECTION 2. Subchapter B, Chapter 132, Education Code, is 22 amended by adding Section 132.026 to read as follows: 23 Sec. 132.026. MEASURES TO FACILITATE AWARD OF COURSE CREDIT 24 FOR MILITARY SERVICE. (a) The commission shall evaluate programs

of study or courses offered by career schools or colleges leading to 1 industry-based certifications or other workforce credentials to 2 identify programs or courses for which skills obtained through 3 military experience, education, and training frequently align. 4

5 (b) The board shall publish on its Internet website a list of any programs of study or courses identified by the commission 6 7 under this section and the relevant military experience, education, 8 or training that may align with those programs or courses.

SECTION 3. Section 132.055, Education Code, is amended by 9 10 adding Subsection (c) to read as follows:

(c) In determining whether to approve a career school or 11 12 college that offers a program of study or course listed on the commission's Internet website under Section 132.026(b), in 13 14 addition to the criteria prescribed by Subsection (b) of this 15 section, the commission shall require that the career school or college provide credit to a student toward any course time required 16 17 for the program of study or course for skills obtained by the student through military experience, education, or training, 18 19 unless the school or college can demonstrate that those skills are not appropriately aligned with the program of study or course. 20

21 SECTION 4. Section 302.0031, Labor Code, is amended by amending Subsection (a) and adding Subsection (h) to read as 22 23 follows:

24 (a) In this section:

(1) "Career school or college" has the meaning 25 26 assigned by Section 132.001, Education Code.

(2) "Institution[, "institution] of higher education" 27

2	(h) Under the program, the commission shall identify,
