## A BILL TO BE ENTITLED

1 AN ACT 2 relating to the sentencing procedures and punishment for the offense of prostitution and to programs for certain defendants 3 charged with or convicted of prostitution. 4 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Chapter 42, Code of Criminal Procedure, is 6 7 amended by adding Article 42.021 to read as follows: Art. 42.021. USE OF SCREENING TOOL FOR SENTENCING PURPOSES 8 9 IN CERTAIN PROSTITUTION CASES. In a case in which the judge will assess punishment for a defendant convicted of an offense under 10 Section 43.02(a), Penal Code, the judge shall use the screening 11 tool developed under Section 72.033, Government Code, to determine 12 whether the defendant is a victim of human trafficking and to inform 13 14 the judge's sentencing decision. SECTION 2. Article 42A.551, Code of Criminal Procedure, is 15 16 amended by adding Subsection (a-1) and amending Subsection (d) to read as follows: 17 18 (a-1) Notwithstanding Subsection (b), on the defendant's conviction of a state jail felony under Section 43.02(c)(2), Penal 19 Code, that is punished under Section 12.35(a), Penal Code, the 20 judge shall suspend the imposition of the sentence and place the 21 defendant on community supervision. This subsection does not apply 22 23 to a defendant who has previously been convicted of any other state

jail felony under Section 43.02(c)(2), Penal Code, that is punished

- 19 in a program operated under Section 507.035, Government Code.
- SECTION 4. Article 55.01, Code of Criminal Procedure, is
- 21 amended by amending Subsection (a) and adding Subsection (a-4) to
- 22 read as follows:
- 23 (a) A person who has been placed under a custodial or
- 24 noncustodial arrest for commission of either a felony or
- 25 misdemeanor is entitled to have all records and files relating to
- 26 the arrest expunged if:
- 27 (1) the person is tried for the offense for which the

- 2 (A) acquitted by the trial court, except as
- 3 provided by Subsection (c); or
- 4 (B) convicted and subsequently:
- 5 (i) pardoned for a reason other than that
- 6 described by Subparagraph (ii); or
- 7 (ii) pardoned or otherwise granted relief
- 8 on the basis of actual innocence with respect to that offense, if
- 9 the applicable pardon or court order clearly indicates on its face
- 10 that the pardon or order was granted or rendered on the basis of the
- 11 person's actual innocence; or
- 12 (2) the person has been released and the charge, if
- 13 any, has not resulted in a final conviction and is no longer pending
- 14 and there was no court-ordered community supervision under Chapter
- 15 42A for the offense, unless the offense is a Class C misdemeanor,
- 16 provided that:
- 17 (A) regardless of whether any statute of
- 18 limitations exists for the offense and whether any limitations
- 19 period for the offense has expired, an indictment or information
- 20 charging the person with the commission of a misdemeanor offense
- 21 based on the person's arrest or charging the person with the
- 22 commission of any felony offense arising out of the same
- 23 transaction for which the person was arrested:
- 24 (i) has not been presented against the
- 25 person at any time following the arrest, and:
- 26 (a) at least 180 days have elapsed
- 27 from the date of arrest if the arrest for which the expunction was

- 1 sought was for an offense punishable as a Class C misdemeanor and if
- 2 there was no felony charge arising out of the same transaction for
- 3 which the person was arrested;
- 4 (b) at least one year has elapsed from
- 5 the date of arrest if the arrest for which the expunction was sought
- 6 was for an offense punishable as a Class B or A misdemeanor and if
- 7 there was no felony charge arising out of the same transaction for
- 8 which the person was arrested;
- 9 (c) at least three years have elapsed
- 10 from the date of arrest if the arrest for which the expunction was
- 11 sought was for an offense punishable as a felony or if there was a
- 12 felony charge arising out of the same transaction for which the
- 13 person was arrested; or
- 14 (d) the attorney representing the
- 15 state certifies that the applicable arrest records and files are
- 16 not needed for use in any criminal investigation or prosecution,
- 17 including an investigation or prosecution of another person; or
- 18 (ii) if presented at any time following the
- 19 arrest, was dismissed or quashed, and the court finds that the
- 20 indictment or information was dismissed or quashed because:
- 21 (a) the person completed a veterans
- 22 treatment court program created under Chapter 124, Government Code,
- 23 or former law, subject to Subsection (a-3);
- 24 (b) the person completed a pretrial
- 25 intervention program authorized under Section 76.011, Government
- 26 Code, other than specialty [a veterans treatment] court programs
- 27 [program] created under Chapter 124 or 126, Government Code, or

- 20 PROSTITUTION OFFENDERS. (a) The department, in consultation with
- 21 the Health and Human Services Commission, shall establish and
- 22 <u>administer a rehabilitation program for defendants placed on</u>
- 23 community supervision and required to participate in the program
- 24 under Article 42A.554(d), Code of Criminal Procedure.

13	SECTION 9. (a) Not later than December 1, 2019, the Office
14	of Court Administration of the Texas Judicial System shall develop
15	and make available the screening tool as required by Section
16	72.033, Government Code, as added by this Act.
17	(b) Article 42.021, Code of Criminal Procedure, as added by
18	this Act, applies only to a defendant who is sentenced for an
19	offense on or after December 1, 2019, regardless of whether the
20	offense is committed before, on, or after that date.
21	SECTION 10. Not later than September 1, 2020, the Texas
22	Department of Criminal Justice shall establish the rehabilitation
23	program required by Section 507.035, Government Code, as added by
24	this Act.
25	SECTION 11. Articles $42A.551(a-1)$ and $42A.554(d)$ , Code of
26	Criminal Procedure, as added by this Act, apply only to an offense
27	committed on or after September 1, 2020. An offense committed

- 1 before September 1, 2020, is governed by the law in effect
- 2 immediately before the effective date of this Act, and the former
- 3 law is continued in effect for that purpose. For purposes of this
- 4 section, an offense was committed before September 1, 2020, if any
- 5 element of the offense occurred before that date.
- 6 SECTION 12. (a) Articles 55.01 and 55.02, Code of Criminal
- 7 Procedure, as amended by this Act, apply to the expunction of arrest
- 8 records and files for a person who successfully completes a
- 9 commercially sexually exploited persons court program under
- 10 Chapter 126, Government Code, or former law before, on, or after the
- 11 effective date of this Act, regardless of when the underlying
- 12 arrest occurred.
- 13 (b) For a person who is entitled to expunction under Article
- 14 55.01(a)(2)(A)(ii)(e), Code of Criminal Procedure, as added by this
- 15 Act, based on a successful completion of a commercially sexually
- 16 exploited persons court program under Chapter 126, Government Code,
- 17 or former law before the effective date of this Act,
- 18 notwithstanding the 30-day time limit provided for the court to
- 19 enter an automatic order of expunction under Section 1a(a-2),
- 20 Article 55.02, Code of Criminal Procedure, as added by this Act, the
- 21 court may, with the consent of the attorney representing the state,
- 22 enter an order of expunction for the person as soon as practicable
- 23 after the court receives written notice from any party to the case
- 24 about the person's entitlement to the expunction.
- 25 SECTION 13. This Act takes effect September 1, 2019.
