#### A BILL TO BE ENTITLED 1 AN ACT 2 relating to nonsubstantive additions to, revisions of, and corrections in enacted codes, to the nonsubstantive codification or 3 disposition of various laws omitted from enacted codes, and to 4 5 conforming codifications enacted by the 85th Legislature to other Acts of that legislature. 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 7 ARTICLE 1. GENERAL PROVISIONS 8 SECTION 1.001. This Act is enacted as part of the state's 9 10 continuing statutory revision program under Chapter 323, 11 Government Code. This Act is a revision for purposes of Section 43, 12 Article III, Texas Constitution, and has the purposes of: 13 (1) codifying without substantive change or providing 14 for other appropriate disposition of various statutes that were omitted from enacted codes; 15 (2) conforming codifications enacted by the 85th 16 Legislature to other Acts of that legislature that amended the laws 17 codified or added new law to subject matter codified; 18 (3) revising without substantive change provisions in 19 enacted codes; 20 21 (4) making necessary corrections to enacted codes; and 22 (5) renumbering or otherwise redesignating titles, 23 chapters, and sections of codes that duplicate title, chapter, or section designations. 24

1 SECTION 1.002. (a) The repeal of a statute by this Act does 2 not affect an amendment, revision, or reenactment of the statute by 3 the 86th Legislature, Regular Session, 2019. The amendment, 4 revision, or reenactment is preserved and given effect as part of 5 the code provision that revised the statute so amended, revised, or 6 reenacted.

another by false or misleading representation of facts;

26 (10) advertising goods or services with intent not to27 supply a reasonable expectable public demand, unless the

SECTION 4.001. Article 5.07, Code of Criminal Procedure, is transferred to Chapter 13, Code of Criminal Procedure, and redesignated as Article 13.38, Code of Criminal Procedure.

SECTION 4.002. Article 5.08, Code of Criminal Procedure, is amended to conform to the amendment of Article 42A.301, Code of Criminal Procedure, by Chapter 109 (S.B. 1584), Acts of the 85th Legislature, Regular Session, 2017, to read as follows:

Art. 5.08. MEDIATION 1 ΙN FAMILY VIOLENCE CASES. Notwithstanding Article 26.13(g) or <u>42A.301(b)(15)</u> [42A.301(15)], 2 3 in a criminal prosecution arising from family violence, as that term is defined by Section 71.004, Family Code, a court shall not 4 5 refer or order the victim or the defendant involved to mediation, dispute resolution, arbitration, or other similar procedures. 6

7 SECTION 4.003. Article 16.22(a), Code of Criminal 8 Procedure, as amended by Chapters 748 (S.B. 1326) and 950 (S.B. 9 1849), Acts of the 85th Legislature, Regular Session, 2017, is 10 reenacted to read as follows:

(a)(1) Not later than 12 hours after the sheriff 11 or 12 municipal jailer having custody of a defendant for an offense punishable as a Class B misdemeanor or any higher category of 13 14 offense receives credible information that may establish 15 reasonable cause to believe that the defendant has a mental illness or is a person with an intellectual disability, the sheriff or 16 17 municipal jailer shall provide written or electronic notice to the magistrate. The notice must include any information related to the 18 19 sheriff's or municipal jailer's determination, such as information regarding the defendant's behavior immediately before, during, and 20 after the defendant's arrest and, if applicable, the results of any 21 previous assessment of the defendant. On a determination that 22 there is reasonable cause to believe that the defendant has a mental 23 24 illness or is a person with an intellectual disability, the magistrate, except as provided by Subdivision (2), shall order the 25 26 local mental health authority, local intellectual and developmental disability authority, or another qualified mental 27

1 health or intellectual disability expert to:

(A) collect information regarding whether the
defendant has a mental illness as defined by Section 571.003,
Health and Safety Code, or is a person with an intellectual
disability as defined by Section 591.003, Health and Safety Code,
including, if applicable, information obtained from any previous
assessment of the defendant and information regarding any
previously recommended treatment; and

magistrate 9 (B) provide to the а written 10 assessment of the information collected under Paragraph (A) on the form approved by the Texas Correctional Office on Offenders with 11 12 Medical or Mental Impairments under Section 614.0032(b), Health and Safety Code. 13

14 (2)The magistrate is not required to order the 15 collection of information under Subdivision (1) if the defendant in the year preceding the defendant's applicable date of arrest has 16 17 been determined to have a mental illness or to be a person with an intellectual disability by the local mental health authority, local 18 19 intellectual and developmental disability authority, or another mental health or intellectual disability expert described by 20 21 Subdivision (1). A court that elects to use the results of that previous determination may proceed under Subsection (c). 22

(3) If the defendant fails or refuses to submit to the collection of information regarding the defendant as required under Subdivision (1), the magistrate may order the defendant to submit to an examination in a jail or in another place determined to be appropriate by the local mental health authority or local

1 intellectual and developmental disability authority for a 2 reasonable period not to exceed 72 hours. If applicable, the county 3 in which the committing court is located shall reimburse the local 4 mental health authority or local intellectual and developmental 5 disability authority for the mileage and per diem expenses of the 6 personnel required to transport the defendant, calculated in 7 accordance with the state travel regulations in effect at the time.

8 SECTION 4.004. Articles 18.01(c), (d), (e), (g), (h), and 9 (j), Code of Criminal Procedure, are amended to correct references 10 to read as follows:

(c) A search warrant may not be issued under Article 11 12 18.02(a)(10) [18.02(10)] unless the sworn affidavit required by Subsection (b) sets forth sufficient facts to establish probable 13 14 cause: (1) that a specific offense has been committed, (2) that the 15 specifically described property or items that are to be searched for or seized constitute evidence of that offense or evidence that a 16 17 particular person committed that offense, and (3) that the property or items constituting evidence to be searched for or seized are 18 19 located at or on the particular person, place, or thing to be 20 searched. Except as provided by Subsections (d), (i), and (j), only a judge of a municipal court of record or a county court who is an 21 attorney licensed by the State of Texas, a statutory county court 22 judge, a district court judge, a judge of the Court of Criminal 23 24 Appeals, including the presiding judge, a justice of the Supreme Court of Texas, including the chief justice, or a magistrate with 25 26 jurisdiction over criminal cases serving a district court may issue warrants under Article 18.02(a)(10) [18.02(10)]. 27

(d) Only the specifically described property or items set 1 forth in a search warrant issued under [Subdivision (10) of] 2 Article <u>18.02(a)(10)</u> [<del>18.02 of this code</del>] or property, items or 3 contraband enumerated in [Subdivisions (1) through (9) or in 4 5 Subdivision (12) of Article 18.02(a)(1), (2), (3), (4), (5), (6), (7), (8), (9), or (12) [18.02 of this code] may be seized. A 6 subsequent search warrant may be issued pursuant to [Subdivision 7 (10) of] Article 18.02(a)(10) [18.02 of this code] to search the 8 same person, place, or thing subjected to a prior search under 9 [Subdivision (10) of] Article <u>18.02(a)(10)</u> [<u>18.02</u> of this code] 10 only if the subsequent search warrant is issued by a judge of a 11 12 district court, a court of appeals, the court of criminal appeals, 13 or the supreme court.

(e) A search warrant may not be issued under [Subdivision 14 15 (10) of] Article <u>18.02(a)(10)</u> [<u>18.02 of this code</u>] to search for and seize property or items that are not described in Article 16 17 18.02(a)(1), (2), (3), (4), (5), (6), (7), (8), or [Subdivisions (1) through] (9) [of that article] and that are located in an office 18 of a newspaper, news magazine, television station, or radio 19 station, and in no event may property or items not described in 20 Article 18.02(a)(1), (2), (3), (4), (5), (6), (7), (8), or 21 [Subdivisions (1) through] (9) [of that article] be legally seized 22 23 in any search pursuant to a search warrant of an office of a 24 newspaper, news magazine, television station, or radio station.

(g) A search warrant may not be issued under [Subdivision (12),] Article <u>18.02(a)(12)</u> [<u>18.02, of this code</u>] unless the sworn affidavit required by Subsection (b) of this article sets forth

1 sufficient facts to establish probable cause that a specific felony 2 offense has been committed and that the specifically described 3 property or items that are to be searched for or seized constitute 4 contraband as defined in Article 59.01 of this code and are located 5 at or on the particular person, place, or thing to be searched.

(h) Except as provided by Subsection (i) of this article, a
7 warrant under [Subdivision (12),] Article <u>18.02(a)(12)</u> [<u>18.02 of</u>
8 this code] may only be issued by:

9 (1) a judge of a municipal court of record who is an 10 attorney licensed by the state;

11 (2) a judge of a county court who is an attorney 12 licensed by the state; or

(3) a judge of a statutory county court, districtcourt, the court of criminal appeals, or the supreme court.

(j) Any magistrate who is an attorney licensed by this state may issue a search warrant under Article <u>18.02(a)(10)</u> [<del>18.02(10)</del>] to collect a blood specimen from a person who:

person for the purpose of connecting that person to an offense may
be executed in any county in this state.

(i) In a revocation hearing at which it is alleged only that the defendant violated the conditions of community supervision by failing to pay community supervision fees or court costs or by
