H.B. No. 4170

A BILL TO BE ENTITLED

1 AN ACT
2 relating to nonsubstantive additions to, revisions of, and
3 corrections in enacted codes, to the nonsubstantive codification or
4 disposition of various laws omitted from enacted codes, and to
5 conforming codifications enacted by the 85th Legislature to other
6 Acts of that legislature.

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

8 ARTICLE 1. GENERAL PROVISIONS

9 SECTION 1.001. This Act is enacted as part of the state's
10 continuing statutory revision program under Chapter 323,
11 Government Code. This Act is a revision for purposes of Section 43,
12 Article III, Texas Constitution, and has the purposes of:

13 (1) codifying without substantive change or providing
14 for other appropriate disposition of various statutes that were
15 omitted from enacted codes;

16 (2) conforming codifications enacted by the 85th
17 Legislature to other Acts of that legislature that amended the laws
18 codified or added new law to subject matter codified;

19 (3) revising without substantive change provisions in
20 enacted codes;

21 (4) making necessary corrections to enacted codes; and

22 (5) renumbering or otherwise redesignating titles,
23 chapters, and sections of codes that duplicate title, chapter, or
24 section designations.

1 SECTION 1.002. (a) The repeal of a statute by this Act does
2 not affect an amendment, revision, or reenactment of the statute by
3 the 86th Legislature, Regular Session, 2019. The amendment,
4 revision, or reenactment is preserved and given effect as part of
5 the code provision that revised the statute so amended, revised, or
6 reenacted.

7 (b) If any provision of this Act conflicts with a statute
8 enacted by the 86th Legislature, Regular Session, 2019, the statute
9 controls.

10 SECTION 1.003. (a) A transition or saving provision of a
11 law codified by this Act applies to the codified law to the same
12 extent as it applied to the original law.

13 (b) The repeal of a transition or saving provision by this
14 Act does not affect the application of the provision to the codified
15 law.

16 (c) In this section, "transition provision" includes any
17 temporary provision providing for a special situation in the
18 transition period between the existing law and the establishment or
19 implementation of the new law.

20 SECTION 1.004. (a) The repeal of a law, including a
21 validating law, by this Act does not remove, void, or otherwise
22 affect in any manner a validation under the repealed law. The
23 validation is preserved and continues to have the same effect that
24 it would have if the law were not repealed.

25 (b) Subsection (a) of this section does not diminish the
26 saving provisions prescribed by Section [311.031](#), Government Code.

1 ARTICLE 2. CHANGES RELATING TO AGRICULTURE CODE

2 SECTION 2.001. Chapter 77, Agriculture Code, is amended to
3 conform to Section 9, Chapter 755 (S.B. 1731), Acts of the 85th
4 Legislature, Regular Session, 2017, to read as follows:

5 CHAPTER 77. FIRE ANT CONTROL

6 ~~[SUBCHAPTER A. ERADICATION PROGRAM]~~

7 Sec. 77.001. COMMISSIONERS COURT MAY ESTABLISH PROGRAM.
8 The commissioners court of any county may establish, implement, and
9 conduct a program for the eradication or control of the imported
10 fire ant.

11 Sec. 77.002. COORDINATION WITH OTHER PROGRAMS. The program
12 established under this chapter may be conducted independently of or
13 in conjunction with any related program conducted and financed by
14 private or other public entities.

15 Sec. 77.003. COST OF PROGRAM. The commissioners court may
16 expend any available county funds to pay for all or its share of the
17 cost of a program established under this chapter, including funds
18 derived from taxation under the 80-cent limitation of Article VIII,
19 Section 9, of the Texas Constitution.

21 ARTICLE 3. CHANGES RELATING TO BUSINESS & COMMERCE CODE

22 SECTION 3.001. Section 17.46(b), Business & Commerce Code,
23 as amended by Chapters 324 (S.B. 1488), 858 (H.B. 2552), and 967
24 (S.B. 2065), Acts of the 85th Legislature, Regular Session, 2017,
25 is reenacted and amended to read as follows:

26 (b) Except as provided in Subsection (d) of this section,
27 the term "false, misleading, or deceptive acts or practices"

1 includes, but is not limited to, the following acts:

2 (1) passing off goods or services as those of another;

3 (2) causing confusion or misunderstanding as to the
4 source, sponsorship, approval, or certification of goods or
5 services;

6 (3) causing confusion or misunderstanding as to
7 affiliation, connection, or association with, or certification by,
8 another;

9 (4) using deceptive representations or designations
10 of geographic origin in connection with goods or services;

11 (5) representing that goods or services have
12 sponsorship, approval, characteristics, ingredients, uses,
13 benefits, or quantities which they do not have or that a person has
14 a sponsorship, approval, status, affiliation, or connection which
15 the person does not;

16 (6) representing that goods are original or new if
17 they are deteriorated, reconditioned, reclaimed, used, or
18 secondhand;

19 (7) representing that goods or services are of a
20 particular standard, quality, or grade, or that goods are of a
21 particular style or model, if they are of another;

22 (8) disparaging the goods, services, or business of
23 another by false or misleading representation of facts;

24 (9) advertising goods or services with intent not to
25 sell them as advertised;

26 (10) advertising goods or services with intent not to
27 supply a reasonable expectable public demand, unless the

1 advertisements disclosed a limitation of quantity;

2 (11) making false or misleading statements of fact
3 concerning the reasons for, existence of, or amount of price
4 reductions;

5 (12) representing that an agreement confers or
6 involves rights, remedies, or obligations which it does not have or
7 involve, or which are prohibited by law;

8 (13) knowingly making false or misleading statements
9 of fact concerning the need for parts, replacement, or repair
10 service;

11 (14) misrepresenting the authority of a salesman,
12 representative or agent to negotiate the final terms of a consumer
13 transaction;

14 (15) basing a charge for the repair of any item in
15 whole or in part on a guaranty or warranty instead of on the value of
16 the actual repairs made or work to be performed on the item without
17 stating separately the charges for the work and the charge for the
18 warranty or guaranty, if any;

19 (16) disconnecting, turning back, or resetting the
20 odometer of any motor vehicle so as to reduce the number of miles
21 indicated on the odometer gauge;

22 (17) advertising of any sale by fraudulently
23 representing that a person is going out of business;

24 (18) advertising, selling, or distributing a card
25 which purports to be a prescription drug identification card issued
26 under Section [4151.152](#), Insurance Code, in accordance with rules
27 adopted by the commissioner of insurance, which offers a discount

1 on the purchase of health care goods or services from a third party
2 provider, and which is not evidence of insurance coverage, unless:

3 (A) the discount is authorized under an agreement
4 between the seller of the card and the provider of those goods and
5 services or the discount or card is offered to members of the
6 seller;

7 (B) the seller does not represent that the card
8 provides insurance coverage of any kind; and

9 (C) the discount is not false, misleading, or
10 deceptive;

11 (19) using or employing a chain referral sales plan in
12 connection with the sale or offer to sell of goods, merchandise, or
13 anything of value, which uses the sales technique, plan,
14 arrangement, or agreement in which the buyer or prospective buyer
15 is offered the opportunity to purchase merchandise or goods and in
16 connection with the purchase receives the seller's promise or
17 representation that the buyer shall have the right to receive
18 compensation or consideration in any form for furnishing to the
19 seller the names of other prospective buyers if receipt of the
20 compensation or consideration is contingent upon the occurrence of
21 an event subsequent to the time the buyer purchases the merchandise
22 or goods;

23 (20) representing that a guaranty or warranty confers
24 or involves rights or remedies which it does not have or involve,
25 provided, however, that nothing in this subchapter shall be
26 construed to expand the implied warranty of merchantability as
27 defined in Sections 2.314 through 2.318 and Sections 2A.212 through

1 2A.216 to involve obligations in excess of those which are
2 appropriate to the goods;

3 (21) promoting a pyramid promotional scheme, as
4 defined by Section 17.461;

5 (22) representing that work or services have been
6 performed on, or parts replaced in, goods when the work or services
7 were not performed or the parts replaced;

8 (23) filing suit founded upon a written contractual
9 obligation of and signed by the defendant to pay money arising out
10 of or based on a consumer transaction for goods, services, loans, or
11 extensions of credit intended primarily for personal, family,
12 household, or agricultural use in any county other than in the
13 county in which the defendant resides at the time of the
14 commencement of the action or in the county in which the defendant
15 in fact signed the contract; provided, however, that a violation of
16 this subsection shall not occur where it is shown by the person
17 filing such suit that the person neither knew or had reason to know
18 that the county in which such suit was filed was neither the county
19 in which the defendant resides at the commencement of the suit nor
20 the county in which the defendant in fact signed the contract;

21 (24) failing to disclose information concerning goods
22 or services which was known at the time of the transaction if such
23 failure to disclose such information was intended to induce the
24 consumer into a transaction into which the consumer would not have
25 entered had the information been disclosed;

26 (25) using the term "corporation," "incorporated," or
27 an abbreviation of either of those terms in the name of a business

1 entity that is not incorporated under the laws of this state or
2 another jurisdiction;

3 (26) selling, offering to sell, or illegally promoting
4 an annuity contract under Chapter 22, Acts of the 57th Legislature,
5 3rd Called Session, 1962 (Article 6228a-5, Vernon's Texas Civil
6 Statutes), with the intent that the annuity contract will be the
7 subject of a salary reduction agreement, as defined by that Act, if
8 the annuity contract is not an eligible qualified investment under
9 that Act or is not registered with the Teacher Retirement System of
10 Texas as required by Section 8A of that Act;

11 (27) taking advantage of a disaster declared by the
12 governor under Chapter 418, Government Code, by:

13 (A) selling or leasing fuel, food, medicine, or
14 another necessity at an exorbitant or excessive price; or

15 (B) demanding an exorbitant or excessive price in
16 connection with the sale or lease of fuel, food, medicine, or
17 another necessity;

18 (28) using the translation into a foreign language of
19 a title or other word, including "attorney," "immigration
20 consultant," "immigration expert," "lawyer," "licensed," "notary,"
21 and "notary public," in any written or electronic material,
22 including an advertisement, a business card, a letterhead,
23 stationery, a website, or an online video, in reference to a person
24 who is not an attorney in order to imply that the person is
25 authorized to practice law in the United States;

26 (29) delivering or distributing a solicitation in
27 connection with a good or service that:

1 (A) represents that the solicitation is sent on
2 behalf of a governmental entity when it is not; or

3 (B) resembles a governmental notice or form that
4 represents or implies that a criminal penalty may be imposed if the
5 recipient does not remit payment for the good or service;

6 (30) delivering or distributing a solicitation in
7 connection with a good or service that resembles a check or other
8 negotiable instrument or invoice, unless the portion of the
9 solicitation that resembles a check or other negotiable instrument
10 or invoice includes the following notice, clearly and conspicuously
11 printed in at least 18-point type:

12 "SPECIMEN-NON-NEGOTIABLE";

13 (31) in the production, sale, distribution, or
14 promotion of a synthetic substance that produces and is intended to
15 produce an effect when consumed or ingested similar to, or in excess
16 of, the effect of a controlled substance or controlled substance
17 analogue, as those terms are defined by Section 481.002, Health and
18 Safety Code:

19 (A) making a deceptive representation or
20 designation about the synthetic substance; or

21 (B) causing confusion or misunderstanding as to
22 the effects the synthetic substance causes when consumed or
23 ingested;

24 (32) a licensed public insurance adjuster directly or
25 indirectly soliciting employment, as defined by Section 38.01,
26 Penal Code, for an attorney, or a licensed public insurance
27 adjuster entering into a contract with an insured for the primary

1 purpose of referring the insured to an attorney without the intent
2 to actually perform the services customarily provided by a licensed
3 public insurance adjuster, provided that this subdivision may not
4 be construed to prohibit a licensed public insurance adjuster from
5 recommending a particular attorney to an insured; ~~[or]~~

6 (33) owning, operating, maintaining, or advertising a
7 massage establishment, as defined by Section 455.001, Occupations
8 Code, that:

9 (A) is not appropriately licensed under Chapter
10 455, Occupations Code, or is not in compliance with the applicable
11 licensing and other requirements of that chapter; or

12 (B) is not in compliance with an applicable local
13 ordinance relating to the licensing or regulation of massage
14 establishments; or

15 (34) ~~[(33)]~~ a warrantor of a vehicle protection
16 product warranty using, in connection with the product, a name that
17 includes "casualty," "surety," "insurance," "mutual," or any other
18 word descriptive of an insurance business, including property or
19 casualty insurance, or a surety business.

20 ARTICLE 4. CHANGES RELATING TO CODE OF CRIMINAL PROCEDURE

21 SECTION 4.001. Article 5.07, Code of Criminal Procedure, is
22 transferred to Chapter 13, Code of Criminal Procedure, and
23 redesignated as Article 13.38, Code of Criminal Procedure.

24 SECTION 4.002. Article 5.08, Code of Criminal Procedure, is
25 amended to conform to the amendment of Article 42A.301, Code of
26 Criminal Procedure, by Chapter 109 (S.B. 1584), Acts of the 85th
27 Legislature, Regular Session, 2017, to read as follows:

1 Art. 5.08. MEDIATION IN FAMILY VIOLENCE CASES.
2 Notwithstanding Article 26.13(g) or 42A.301(b)(15) [~~42A.301(15)~~],
3 in a criminal prosecution arising from family violence, as that
4 term is defined by Section 71.004, Family Code, a court shall not
5 refer or order the victim or the defendant involved to mediation,
6 dispute resolution, arbitration, or other similar procedures.

7 SECTION 4.003. Article 16.22(a), Code of Criminal
8 Procedure, as amended by Chapters 748 (S.B. 1326) and 950 (S.B.
9 1849), Acts of the 85th Legislature, Regular Session, 2017, is
10 reenacted to read as follows:

11 (a)(1) Not later than 12 hours after the sheriff or
12 municipal jailer having custody of a defendant for an offense
13 punishable as a Class B misdemeanor or any higher category of
14 offense receives credible information that may establish
15 reasonable cause to believe that the defendant has a mental illness
16 or is a person with an intellectual disability, the sheriff or
17 municipal jailer shall provide written or electronic notice to the
18 magistrate. The notice must include any information related to the
19 sheriff's or municipal jailer's determination, such as information
20 regarding the defendant's behavior immediately before, during, and
21 after the defendant's arrest and, if applicable, the results of any
22 previous assessment of the defendant. On a determination that
23 there is reasonable cause to believe that the defendant has a mental
24 illness or is a person with an intellectual disability, the
25 magistrate, except as provided by Subdivision (2), shall order the
26 local mental health authority, local intellectual and
27 developmental disability authority, or another qualified mental

1 health or intellectual disability expert to:

2 (A) collect information regarding whether the
3 defendant has a mental illness as defined by Section 571.003,
4 Health and Safety Code, or is a person with an intellectual
5 disability as defined by Section 591.003, Health and Safety Code,
6 including, if applicable, information obtained from any previous
7 assessment of the defendant and information regarding any
8 previously recommended treatment; and

9 (B) provide to the magistrate a written
10 assessment of the information collected under Paragraph (A) on the
11 form approved by the Texas Correctional Office on Offenders with
12 Medical or Mental Impairments under Section 614.0032(b), Health and
13 Safety Code.

14 (2) The magistrate is not required to order the
15 collection of information under Subdivision (1) if the defendant in
16 the year preceding the defendant's applicable date of arrest has
17 been determined to have a mental illness or to be a person with an
18 intellectual disability by the local mental health authority, local
19 intellectual and developmental disability authority, or another
20 mental health or intellectual disability expert described by
21 Subdivision (1). A court that elects to use the results of that
22 previous determination may proceed under Subsection (c).

23 (3) If the defendant fails or refuses to submit to the
24 collection of information regarding the defendant as required under
25 Subdivision (1), the magistrate may order the defendant to submit
26 to an examination in a jail or in another place determined to be
27 appropriate by the local mental health authority or local

1 intellectual and developmental disability authority for a
2 reasonable period not to exceed 72 hours. If applicable, the county
3 in which the committing court is located shall reimburse the local
4 mental health authority or local intellectual and developmental
5 disability authority for the mileage and per diem expenses of the
6 personnel required to transport the defendant, calculated in
7 accordance with the state travel regulations in effect at the time.

8 SECTION 4.004. Articles [18.01\(c\)](#), (d), (e), (g), (h), and
9 (j), Code of Criminal Procedure, are amended to correct references
10 to read as follows:

11 (c) A search warrant may not be issued under Article
12 [18.02\(a\)\(10\)](#) [~~[18.02\(10\)](#)~~] unless the sworn affidavit required by
13 Subsection (b) sets forth sufficient facts to establish probable
14 cause: (1) that a specific offense has been committed, (2) that the
15 specifically described property or items that are to be searched
16 for or seized constitute evidence of that offense or evidence that a
17 particular person committed that offense, and (3) that the property
18 or items constituting evidence to be searched for or seized are
19 located at or on the particular person, place, or thing to be
20 searched. Except as provided by Subsections (d), (i), and (j), only
21 a judge of a municipal court of record or a county court who is an
22 attorney licensed by the State of Texas, a statutory county court
23 judge, a district court judge, a judge of the Court of Criminal
24 Appeals, including the presiding judge, a justice of the Supreme
25 Court of Texas, including the chief justice, or a magistrate with
26 jurisdiction over criminal cases serving a district court may issue
27 warrants under Article [18.02\(a\)\(10\)](#) [~~[18.02\(10\)](#)~~].

1 (d) Only the specifically described property or items set
2 forth in a search warrant issued under [~~Subdivision (10) of~~]
3 Article 18.02(a)(10) [~~18.02 of this code~~] or property, items or
4 contraband enumerated in [~~Subdivisions (1) through (9) or in~~
5 ~~Subdivision (12) of~~] Article 18.02(a)(1), (2), (3), (4), (5), (6),
6 (7), (8), (9), or (12) [~~18.02 of this code~~] may be seized. A
7 subsequent search warrant may be issued pursuant to [~~Subdivision~~
8 ~~(10) of~~] Article 18.02(a)(10) [~~18.02 of this code~~] to search the
9 same person, place, or thing subjected to a prior search under
10 [~~Subdivision (10) of~~] Article 18.02(a)(10) [~~18.02 of this code~~]
11 only if the subsequent search warrant is issued by a judge of a
12 district court, a court of appeals, the court of criminal appeals,
13 or the supreme court.

14 (e) A search warrant may not be issued under [~~Subdivision~~
15 ~~(10) of~~] Article 18.02(a)(10) [~~18.02 of this code~~] to search for and
16 seize property or items that are not described in Article
17 18.02(a)(1), (2), (3), (4), (5), (6), (7), (8), or [~~Subdivisions~~
18 ~~(1) through~~] (9) [~~of that article~~] and that are located in an office
19 of a newspaper, news magazine, television station, or radio
20 station, and in no event may property or items not described in
21 Article 18.02(a)(1), (2), (3), (4), (5), (6), (7), (8), or
22 [~~Subdivisions (1) through~~] (9) [~~of that article~~] be legally seized
23 in any search pursuant to a search warrant of an office of a
24 newspaper, news magazine, television station, or radio station.

25 (g) A search warrant may not be issued under [~~Subdivision~~
26 ~~(12),~~] Article 18.02(a)(12) [~~18.02, of this code~~] unless the sworn
27 affidavit required by Subsection (b) of this article sets forth

1 sufficient facts to establish probable cause that a specific felony
2 offense has been committed and that the specifically described
3 property or items that are to be searched for or seized constitute
4 contraband as defined in Article 59.01 of this code and are located
5 at or on the particular person, place, or thing to be searched.

6 (h) Except as provided by Subsection (i) of this article, a
7 warrant under [~~Subdivision (12),~~] Article 18.02(a)(12) [~~18.02 of~~
8 ~~this code~~] may only be issued by:

9 (1) a judge of a municipal court of record who is an
10 attorney licensed by the state;

11 (2) a judge of a county court who is an attorney
12 licensed by the state; or

13 (3) a judge of a statutory county court, district
14 court, the court of criminal appeals, or the supreme court.

15 (j) Any magistrate who is an attorney licensed by this state
16 may issue a search warrant under Article 18.02(a)(10) [~~18.02(10)~~]
17 to collect a blood specimen from a person who:

18 (1) is arrested for an offense under Section 49.04,
19 49.045, 49.05, 49.06, 49.065, 49.07, or 49.08, Penal Code; and

20 (2) refuses to submit to a breath or blood alcohol
21 test.

22 SECTION 4.005. Article 18.065(a), Code of Criminal
23 Procedure, is amended to correct a reference to read as follows:

24 (a) A warrant issued by the judge of a district court under
25 Article 18.02(a)(10) [~~18.02(10)~~] to collect a DNA specimen from a
26 person for the purpose of connecting that person to an offense may
27 be executed in any county in this state.

1 SECTION 4.006. Articles 42A.651(a) and (c), Code of
2 Criminal Procedure, are amended to conform to the amendment of
3 Article 42A.301, Code of Criminal Procedure, by Chapter 109 (S.B.
4 1584), Acts of the 85th Legislature, Regular Session, 2017, to read
5 as follows:

6 (a) A judge may not order a defendant to make a payment as a
7 term or condition of community supervision, except for:

8 (1) the payment of fines, court costs, or restitution
9 to the victim;

10 (2) reimbursement of a county as described by Article
11 42A.301(b)(11) [~~42A.301(11)~~]; or

12 (3) a payment ordered as a condition that relates
13 personally to the rehabilitation of the defendant or that is
14 otherwise expressly authorized by law.

15 (c) A judge may not impose a condition of community
16 supervision requiring a defendant to reimburse a county for the
17 costs of legal services as described by Article 42A.301(b)(11)
18 [~~42A.301(11)~~] if the defendant has already satisfied that
19 obligation under Article 26.05(g).

20 SECTION 4.007. Article 42A.751(i), Code of Criminal
21 Procedure, is amended to conform to the amendment of Article
22 42A.301, Code of Criminal Procedure, by Chapter 109 (S.B. 1584),
23 Acts of the 85th Legislature, Regular Session, 2017, to read as
24 follows:

25 (i) In a revocation hearing at which it is alleged only that
26 the defendant violated the conditions of community supervision by
27 failing to pay community supervision fees or court costs or by

1 failing to pay the costs of legal services as described by Article
2 42A.301(b)(11) [~~42A.301(11)~~], the state must prove by a
3 preponderance of the evidence that the defendant was able to pay and
4 did not pay as ordered by the judge.

5 SECTION 4.008. Article 42A.756, Code of Criminal Procedure,
6 is amended to more accurately reflect the source law from which it
7 was derived to read as follows:

8 Art. 42A.756. DUE DILIGENCE DEFENSE. For the purposes of a
9 hearing under Article 42A.751(d), it is an affirmative defense to
10 revocation for an alleged violation based on a failure to report to
11 a supervision officer as directed or to remain within a specified
12 place that no supervision officer, peace officer, or other officer
13 with the power of arrest under a warrant issued by a judge for that
14 alleged violation contacted or attempted to contact the defendant
15 in person at the defendant's last known residence address or last
16 known employment address, as reflected in the files of the
17 department serving the county in which the order of [~~deferred~~
18 ~~adjudication~~] community supervision was entered.

19 SECTION 4.009. Article 42A.757(a), Code of Criminal
20 Procedure, is amended to more accurately reflect the source law
21 from which it was derived to read as follows:

22 (a) If a defendant is placed on [~~deferred adjudication~~]
23 community supervision after receiving a grant of deferred
24 adjudication community supervision for or being convicted of an
25 offense under Section 21.11, 22.011, or 22.021, Penal Code, at any
26 time during the period of community supervision, the judge may
27 extend the period of community supervision as provided by this

1 article.

2 SECTION 4.010. Article 43.09(h), Code of Criminal
3 Procedure, as amended by Chapters 977 (H.B. 351) and 1127 (S.B.
4 1913), Acts of the 85th Legislature, Regular Session, 2017, is
5 reenacted to read as follows:

6 (h) The court may order the defendant to perform community
7 service under Subsection (f):

8 (1) by attending:

9 (A) a work and job skills training program;

10 (B) a preparatory class for the high school
11 equivalency examination administered under Section 7.111,
12 Education Code;

13 (C) an alcohol or drug abuse program;

14 (D) a rehabilitation program;

15 (E) a counseling program, including a
16 self-improvement program;

17 (F) a mentoring program; or

18 (G) any similar activity; or

19 (2) for:

20 (A) a governmental entity;

21 (B) a nonprofit organization or another
22 organization that provides services to the general public that
23 enhance social welfare and the general well-being of the community,
24 as determined by the court; or

25 (C) an educational institution.

26 SECTION 4.011. Article 45.049(c), Code of Criminal

18 (a) No land within the corporate limits of a city or within
19 the extraterritorial jurisdiction of a city, shall be included in a
20 district unless the city grants its written consent, by resolution
21 or ordinance, to the inclusion of the land within the district in

2 by metes and bounds or by lot and block number, if there is a
3 recorded map or plat and survey of the area, and state the general
4 nature of the work proposed to be done, the necessity for the work,
5 and the cost of the project as then estimated by those filing the
6 petition. If, at the time a petition is filed with a city for
7 creation of a district, the district proposes to connect to a city's
8 water or sewer system or proposes to contract with a regional water
9 and wastewater provider which has been designated as such by the
10 commission as of the date such petition is filed, to which the city
11 has made a capital contribution for the water and wastewater
12 facilities serving the area, the proposed district shall be
13 designated as a "city service district." If such proposed district
14 does not meet the criteria for a city service district at the time
15 the petition seeking creation is filed, such district shall be
16 designated as a "noncity service district." The city's consent
17 shall not place any restrictions or conditions on the creation of a
18 noncity service district as defined by this chapter other than
19 those expressly provided in Subsection (e) of this section and
20 shall specifically not limit the amounts of the district's bonds. A
21 city may not require annexation as a consent to creation of any
22 district. A city shall not refuse to approve a district bond issue
23 for any reason except that the district is not in compliance with
24 valid consent requirements applicable to the district. If a city
25 grants its written consent without the concurrence of the applicant
26 to the creation of a noncity service district containing conditions
27 or restrictions that the petitioning land owner or owners

1 reasonably believe exceed the city's powers, such land owner or
2 owners may petition the commission to create the district and to
3 modify the conditions and restrictions of the city's consent. The
4 commission may declare any provision of the consent to be null and
5 void. The commission may approve the creation of a district that
6 includes any portion of the land covered by the city's consent to
7 creation of the district. The legislature may create and may
8 validate the creation of a district that includes any portion of the
9 land covered by the city's consent to the creation of the district.
