9	Sec. 2003.151. DEFINITIONS. In this subchapter:
10	(1) "Department" means the Texas Department of
11	Insurance.
12	(2) "Panel" means the consumer complaint review panel
13	established under this subchapter.
14	Sec. 2003.152. CONSUMER COMPLAINT REVIEW PANEL. (a) The
15	office shall establish a consumer complaint review panel to conduct
16	an appeal from the complaint resolution program established under
17	Chapter 521, Insurance Code, of a policyholder complaint:
18	(1) that is denied by the department;
19	(2) that is determined to be without merit by the
20	department; or
21	(3) for which the department did not confirm receipt
22	of the complaint.
23	(b) Except as provided by this subchapter, an appeal under
24	this section is a contested case under Chapter 2001.

Sec. 2003.152. TIMELINESS OF APPEAL. (a) The panel shall 1 2 conduct all appeals under this subchapter in a timely manner. (b) The panel shall use every reasonable means to expedite 3 an appeal under this subchapter when the policyholder or department 4 5 provides good cause that the panel expedite the appeal. 6 Sec. 2003.153. CONFIDENTIALITY OF INFORMATION. (a) The 7 panel shall keep information that identifies a policyholder who participates in an appeal under this subchapter confidential, 8 including the policyholder's name and medical condition, if 9 10 applicable. (b) The provision of information to the panel that is 11 12 confidential under any law does not affect the confidentiality of the information, and the panel shall maintain that confidentiality. 13 (c) An appeal conducted under this subchapter 14 is 15 confidential and not open to the public. 16 Sec. 2003.154. DECISION. The panel shall determine whether 17 an appeal conducted under this subchapter has merit and if so, remand the case to the department for resolution. 18 Sec. 2003.155. RULES. The commissioner of insurance may 19 adopt rules necessary to implement this subchapter. 20 21 SECTION 2. Not later than January 1, 2020, the State Office of Administrative Hearings shall establish the consumer complaint 22 review panel under Section 2003.152, Government Code, as added by 23
