Section 1301.002(10), Occupations Code, is amended to read as follows: 6 Sec. 1301.002. DEFINITIONS. In this chapter: 7 (10) "Tradesman plumber-limited license holder" means 8 9 a person who: has completed at least 4,000 hours working 10 (A) 11 under the direct supervision of a journeyman or master plumber as a 12 plumber's apprentice; or has completed the required amount of courses in the plumbing career and technological education program 13 14 as set forth in Sec. 1301.3542; has passed the required examination; 15 (B) 16 (C) constructs and installs plumbing for one-family or two-family dwellings under the supervision of a 17 responsible master plumber; and 18 (D) has fulfilled the other requirements of the 19 20 board. 21 SECTION 2. Subchapter G, Occupations Code, is amended by adding Section 1301.3542 to read as follows: 22 Sec. 1301.3542. TRADESMAN PLUMBER LIMITED-LICENSE CAREER & 23 TECHNOLOGY EDUCATION PROGRAM. (a) 24 Notwithstanding any age

No. 4296 requirements in this chapter, a person who completes a coherent 1 sequence of courses in the plumbing trade offered through a career 2 and technology education program under Subchapter F, Chapter 29, 3 of the Education Code, approved by the State Board of Education, 4 shall be eligible to take the examination for a license as a 5 6 tradesman plumber-limited license holder. The fee and other 7 examination requirements for applicants under this subsection are 8 waived. 9 (b) A person's completion of the plumbing education program in subsection (a) may be verified by an official high school 10 transcript or equivalent. 11 12 (c) If the applicant successfully completes the examination, the board shall issue the applicant a tradesman 13 14 plumber-limited license. 15 (d) A person who pursues a tradesman plumber-limited license under this section is exempt from the plumber apprentice 16 requirements under Section 1301.054(a) and (b). 17 (e) The board may adopt rules to implement this section. 18 SECTION 3. Section 1301.401, Occupations Code, is amended 19 by adding Subsection (a-1) to read as follows: 20 21 Sec. 1301.401. ANNUAL RENEWAL REQUIRED. (a-1) With written verification from the school, a 2.2 journeyman plumber, master plumber, or plumber inspector who, as an 23 24 employee, contractor or volunteer, teaches part-time or full-time for a plumbing career and technology education program pursuant to 25 26 Section 1301.3542, is exempt from the license or registration 27 renewal and fee requirements in subsection (a).

SECTION 4. Section 1301.404, Occupations Code, is amended
by adding Subsection (b-1) to read as follows:

(b-1) A person who holds a license under this chapter, but
