5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subchapter D, Chapter 33, Education Code, is
7	amended by adding Section 33.097 to read as follows:
8	Sec. 33.097. ADAPTIVE SPORTS PROGRAM FOR STUDENTS WITH
9	DISABILITIES. (a) The University Interscholastic League shall
10	ensure students with disabilities have an opportunity to
11	participate in team athletic activities by establishing an adaptive
12	sports program. In establishing the adaptive sports program, the
13	league shall consider and incorporate as appropriate:
14	(1) federal guidance regarding providing access to
15	extracurricular athletics for students with disabilities;
16	(2) guidance available from nationally recognized
17	organizations that provide or promote adaptive athletics;
18	(3) information regarding adaptive sports programs
19	that have been successfully implemented in other states or by
20	nonprofit organizations; and

(b) In establishing the adaptive sports program, the

- 2 subject to the same rules and requirements as students who
- 3 participate in other athletic programs offered by the league,
- 4 including:
- 5 (A) grade and disciplinary requirements under
- 6 Section 33.081(c); and
- 7 <u>(B) requirements related to student safety in</u>
- 8 athletic activities under this chapter and Chapter 38; and
- 9 (2) team sports provided through the program to be
- 10 organized similarly to other athletic programs offered by the
- 11 league, including with respect to team practices, seasonal play,
- 12 and local and statewide competitions.
- 13 (c) In addition to using funds appropriated for the purpose,
- 14 the University Interscholastic League may seek and accept gifts,
- 15 grants, or donations of money from public and private sources for
- 16 the purpose of establishing or expanding the adaptive sports
- 17 program.
- 18 (d) The University Interscholastic League shall adopt rules
- 19 as necessary to establish, maintain, and expand the adaptive sports
- 20 program. The rules must:
- 21 (1) require that team sports offered through the
- 22 program be available to students at public middle schools, junior
- 23 <u>high schools</u>, and high schools in the state;
- 24 (2) establish eligibility requirements for
- 25 participation in each team sport offered through the program; and
- 26 (3) identify best practices for school districts to
- 27 incorporate adaptive sports.
