BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
SECTION 1. Chapter 33, Insurance Code, is amended by adding
Section 33.008 to read as follows:
Sec. 33.008. PROHIBITION AGAINST ACCEPTANCE OF GIFTS,
GRATUITIES, OR OTHER THING OF VALUE; EXCEPTION. (a) Except as
provided by Subsections (b) and (d), the commissioner or an
employee of the department may not accept a gift, gratuity, or other
thing of value, including transportation and travel expenses, from
a person who:
(1) is employed by or participates in the management
of an entity or other organization that is regulated by the
department;
(2) owns or controls, directly or indirectly, more
than a 10 percent interest of a business entity or other
organization that is regulated by the department;
(3) is related within the second degree of
consanguinity to a person described by Subdivision (1) or (2); or
(4) is an agent, representative, attorney, employee,
officer, owner, director, or partner of an entity, organization, or
person described by Subdivision (1), (2), or (3).

<u>gifts, gratuities, or other things of value the aggregate value of</u>
<u>which exceeds \$2,000 during a calendar year.</u>
SECTION 2. Section 33.008, Insurance Code, as added by this
Act, applies only to a gift, gratuity, or thing of value accepted or
given on or after the effective date of this Act.
