8	child [if the district identifies 15 or more children] who is [are
9	eligible under Subsection (b) and are] at least four years of age.
10	A school district may offer prekindergarten classes if the district
11	identifies 15 or more [eligible] children who are eligible under
12	Subsection (b)(1) [at least three years of age]. A district may not
13	charge tuition for a prekindergarten class offered under this

15	(b) A child is eligible for enrollment in a prekindergarten

- 17 (1) at least three years of age and:

- 1 $\underline{\text{(D)}}$ [$\frac{\text{(A)}}{\text{(D)}}$] is the child of an active duty member
- 2 of the armed forces of the United States, including the state

- 5 (E) $\left[\frac{(5)}{(5)}\right]$ is the child of a member of the armed

- 18 district's Public Education Information Management System (PEIMS)

- 20 (1) demographic information, as determined by the

- 24 (2) the numbers of half-day and full-day

- 4 (5) if the district elects to administer an assessment

- 8 (6) curricula used in the district's prekindergarten
- 9 program classes.
- 10 SECTION 4. Subchapter E, Chapter 29, Education Code, is
- 11 amended by adding Section 29.1536 to read as follows:
- 12 Sec. 29.1536. ELIGIBLE PRIVATE PROVIDERS. (a) A school
- 13 district may enter into a contract with an eligible private
- 14 provider to provide services or equipment for or to establish a
- 15 prekindergarten program.
- 16 (b) To be eligible to contract with a school district to
- 17 provide a program or part of a program, a private provider must be
- 18 licensed by and in good standing with the Department of Family and
- 19 Protective Services. For purposes of this section, a private
- 20 provider is in good standing with the Department of Family and
- 21 Protective Services if the department has not taken an action
- 22 against the provider's license under Section 42.071, 42.072, or
- 23 <u>42.078</u>, Human Resources Code, during the 24-month period preceding
- 24 the date of a contract with a school district. The private provider
- 25 must also:
- (1) be accredited by a research-based, nationally
- 27 recognized, and universally accessible accreditation system

- 2 (2) be a Texas Rising Star Program provider with a

- 17 satisfies eligibility requirements under Section 29.153(b) and who
- 18 is enrolled in a program class.
- 19 (c) A student qualifies for additional funding under
- 20 Subsection (b) if the student[+
- 21 [(1) satisfies eligibility requirements under Section
- 22 29.153(b); and
- [(2)] is four years of age on September 1 of the year
- 24 the student begins the program.
- 25 SECTION 6. Section 29.153(d), Education Code, is repealed.
- SECTION 7. This Act applies beginning with the 2019-2020
- 27 school year.
