A member may serve more than 20 one term.
- 21 SECTION 2. (a) Not later than February 1, 2020, governor shall appoint new members to the board of directors of the 22 Texas School Safety Center as required by Section 37.203(a)(6)(I), 23 24 Education Code, as amended by this Act, 37.203(a)(6)(J), Education Code, as added by this Act. 25
- 26 (b) Section 37.203, Education Code, as amended by this Act, 27 does not affect the term of the member appointed under Section
