A BILL TO BE ENTITLED

AN ACT

2 relating to state occupational licensing of certain military 3 veterans and military spouses.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 21.052, Education Code, is amended by 6 amending Subsections (a-1), (b-1), and (f) and adding Subsection 7 (i) to read as follows:

8 (a-1) The commissioner may adopt rules establishing 9 exceptions to the examination requirements prescribed by 10 Subsection (a)(3) for an educator <u>who is a military veteran or</u> 11 <u>military spouse or is</u> from outside the state to obtain a certificate 12 in this state.

13 (b-1) The board shall propose rules in accordance with 14 Sections 55.005 and 55.006, Occupations Code, to establish procedures to expedite the processing of an application for a 15 16 certificate under this section submitted by an educator who is a military veteran or military [the] spouse [of a person who is 17 serving on active duty as a member of the armed forces of the United 18 States], including rules for providing a permanent change of 19 station or military identification card [the appropriate 20 21 documentation to establish the educator's status as a spouse of a person who is serving on active duty as a member of the armed forces 22 23 of the United States].

(f) The board shall post on the board's Internet website the

3	(i) In this section:
4	(1) "Active duty" means current full-time military
5	service in the armed forces of the United States or active duty
6	military service as a member of the Texas military forces, as
7	defined by Section 437.001, Government Code, or similar military
8	service of another state.
9	(2) "Armed forces of the United States" means the
10	army, navy, air force, coast guard, or marine corps of the United
11	States or a reserve unit of one of those branches of the armed
12	forces.
13	(3) "Military service member" means a person who is on
14	active duty.
15	(4) "Military spouse" means a person who is married to
16	a military service member.
17	(5) "Military veteran" means a person who has served
18	on active duty and who was discharged or released from active duty.
19	SECTION 2. Section 55.004, Occupations Code, is amended by
20	adding Subsections (a-1) and (d) to read as follows:
21	(a-1) In adopting rules under Subsection (a), the state
22	agency shall ensure that a military veteran or military spouse
23	receives appropriate credit for the individual's experience,
24	including clinical and professional experience, in a licensed
25	profession.
26	(d) A state agency that issues a license that has a
27	residency requirement for license eligibility shall adopt rules to

1 allow a military spouse applicant to establish residency for purposes of this subsection by providing to the agency a copy of the 2 permanent change of station order for the military service member 3 to whom the spouse is married or the spouse's military 4 5 identification card. 6 SECTION 3. Section 55.010, Occupations Code, is amended to 7 read as follows: Sec. 55.010. NOTICE OF CHAPTER PROVISIONS. 8 (a) In this section, "commission" means the Texas Workforce Commission. 9 10 (b) A state agency that issues a license shall prominently post a notice on the home page of the agency's Internet website 11 12 describing the provisions of this chapter that are available to military service members, military veterans, and military spouses. 13 14 (c) A state agency that issues a license under rules adopted 15 under Section 55.004 shall notify the commission immediately on determining that the requirements of a license of this state are 16 17 substantially equivalent to those of another jurisdiction. (d) The commission shall establish and maintain an Internet 18 19 website to serve as a single location for military veterans and military spouses to access information regarding the issuance of a 20 license by a state agency to a military veteran or military spouse 21 who is licensed in another jurisdiction, including a list of each 22 license of this state and license of another jurisdiction that is 23 24 determined by a state agency to be substantially equivalent. SECTION 4. Section 2, Chapter 1048 (H.B. 1934), Acts of the 25 26 85th Legislature, Regular Session, 2017, is repealed. 27 SECTION 5. Not later than January 1, 2020, the Texas

1 Workforce Commission shall establish the Internet website required
2 by Section 55.010, Occupations Code, as amended by this Act.

3 SECTION 6. The changes in law made by this Act apply only to 4 an initial application for or an application for renewal of an 5 occupational license filed on or after the effective date of this 6 Act. An application for a license filed before the effective date of 7 this Act is governed by the law in effect immediately before that 8 date, and that law is continued in effect for that purpose.

SECTION 7. This Act takes effect September 1, 2019.
