A BILL TO BE ENTITLED 1 AN ACT 2 relating to the regulation of child-care facilities and registered family homes providing services to children with disabilities or 3 special needs. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5 6 SECTION 1. Section 42.042(e), Human Resources Code, is amended to read as follows: 7 (e) The executive commissioner shall promulgate minimum 8 9 standards that apply to licensed child-care facilities and to registered family homes covered by this chapter and that will: 10 11 (1) promote the health, safety, and welfare of 12 children attending a facility or registered family home; 13 (2) promote safe, comfortable, and healthy physical 14 facilities and registered family homes for children; (3) ensure adequate supervision of children 15 by 16 capable, qualified, and healthy personnel that includes an assessment of the wandering history of each child attending the 17 facility or home; 18 (4) ensure adequate and healthy food service where 19 food service is offered; 20 21 (5) prohibit [racial] discrimination on the basis of race or disability status by child-care facilities and registered 22 23 family homes; 24 (6) require procedures for parental and guardian

No. 4450 consultation in the formulation of children's educational and 1 therapeutic programs; 2 3 (7) prevent the breakdown of foster care and adoptive placement; [and] 4 5 (8) ensure that a child-care facility or registered 6 family home: 7 (A) follows the directions of a child's physician 8 or other health care provider in providing specialized medical assistance required by the child; and 9 10 (B) maintains for a reasonable time a copy of any 11 directions from the physician or provider that the parent provides 12 to the facility or home; and 13 (9) ensure that: 14 (A) the facility or home promotes inclusive 15 practices and integrates children with special needs into the general activities of the facility or home; 16 17 (B) the activities of the facility or home are tailored to the strengths and needs of each child attending the 18 19 facility or home based on the child's developmental age and competencies; and 20 21 (C) early childhood intervention service providers have access to children with disabilities who are 22 attending the facility or home to provide services while the 23 24 children are at the facility or home. 25 SECTION 2. Section 42.0421, Human Resources Code, is amended by amending Subsections (a) and (f) and adding Subsections 26

(a-1) and (a-2) to read as follows:

1 (a) The minimum training standards prescribed by the 2 executive commissioner under Section 42.042(p) for an employee, 3 director, or operator of a day-care center, group day-care home, or 4 registered family home must include:

5 (1)24 hours of initial training that must be 6 completed not later than the 90th day after the employee's first day 7 of employment for an employee of a day-care center who has no 8 previous training or less than two years of employment experience in a regulated child-care facility, eight hours of which must be 9 completed before the employee <u>may provide care to</u> [is given 10 responsibility for a group of] children but only under the 11 supervision of another individual who has completed the initial 12 training or has the required experience; 13

14 (2) 24 hours of annual training for each employee of a 15 day-care center or group day-care home, excluding the director, 16 which must include at least six hours of training in one or more of 17 the following areas:

18 (A) child growth and development, including
19 awareness of children with disabilities or developmental delays;

(B) guidance and discipline;

21 (C) age-appropriate curriculum; and

22 (D) teache

(D) teacher-child interaction; and

(3) 30 hours of annual training for each director of a
day-care center or group day-care home, or operator of a registered
family home, which must include at least six hours of training in
one or more of the following areas:

(A) child growth and development;

1 (B) guidance and discipline; 2 (C) age-appropriate curriculum; and 3 (D) teacher-child interaction. 4 (a-1) The minimum training standards prescribed in 5 accordance with Subsection (a)(1) for initial training must 6 include: 7 (1) child mental health training addressing social and emotional learning, positive behavior interventions and supports, 8 and trauma-informed care; and 9 10 (2) training on providing care to children with special needs. 11 12 (a-2) The minimum training standards prescribed in accordance with Subsection (a)(2) or (a)(3) for an employee, 13 14 director, or operator of a day-care center, group day-care home, or 15 registered family home must include as a two-hour component of the annual training special training on providing care to children with 16 17 special needs. The children with special needs training: 18 (1) may be completed through an in-person training or a distance learning course; and 19 (2) must include identification of potential 20 developmental delays, methods for referring children with special 21 needs for specialized services, and information on early childhood 22 intervention and preschool programs for children 23 with 24 disabilities. 25 The training required by this section (f) must be 26 appropriately targeted and relevant to the age of the children who

will receive care from the individual receiving training and must

1 be provided by a person who:

(1) is a training provider registered with the Texas
3 Early Childhood Professional Development System's Texas Trainer
4 Registry that is maintained by the Texas Head Start State
5 Collaboration Office;

6 (2) is an instructor at a public or private secondary 7 school, an institution of higher education, as defined by Section 8 61.003, Education Code, or a private college or university 9 accredited by a recognized accrediting agency who teaches early 10 childhood development or another relevant course, as determined by 11 rules adopted by the commissioner of education and the commissioner 12 of higher education;

13 (3) is an employee of a state agency with relevant14 expertise;

15 (4) is a physician, psychologist, licensed
16 professional counselor, social worker, or registered nurse;

17 (5) holds a generally recognized credential or
18 possesses documented knowledge relevant to the training the person
19 will provide;

(6) is a registered family home care provider or
21 director of a day-care center or group day-care home in good
22 standing with the department, if applicable, and who:

(A) has demonstrated core knowledge in childdevelopment and caregiving; and

(B) is only providing training at the home or
center in which the provider or director and the person receiving
training are employed; [or]

No. 4450 1 (7) has at least two years of experience working in child development, a child development program, early childhood 2 3 education, a childhood education program, or a Head Start or Early Head Start program and: 4 5 (A) has been awarded a Child Development 6 Associate (CDA) credential; or 7 holds at least an associate's degree in child (B) 8 development, early childhood education, or a related field; 9 (8) is an accredited early intervention specialist; 10 (9) is an accredited early childhood intervention service provider; or 11 12 (10) is a Board Certified Behavior Analyst. SECTION 3. Section 42.045(a), Human Resources Code, 13 is 14 amended to read as follows: 15 (a) A person who operates a licensed or certified facility shall maintain individual child development records, individual 16 17 health records, records provided by parents for children with special needs, statistical records, and complete financial 18 records. 19 SECTION 4. Subchapter C, Chapter 42, Human Resources Code, 20 is amended by adding Sections 42.067 and 42.068 to read as follows: 21 Sec. 42.067. REQUIRED PARENTAL DISCLOSURE FOR CHILDREN WITH 22 DISABILITIES. A child-care facility or registered family home 23 24 shall provide written disclosure to a parent or guardian of each child with a disability attending the facility or home that 25 26 includes: 27 (1) an application in the form prescribed by the

2	and contact information for providers of those services;
3	(2) information on the preschool program for children
4	with disabilities; and
5	(3) the policies of the facility or home on providing
6	care to children with disabilities.
7	Sec. 42.068. REPORTING OF SUSPENSION OR EXPULSION OF
8	CHILDREN. A child-care facility or registered family home shall
9	report to the commission in the form and manner prescribed by
10	commission rule each suspension or expulsion of a child attending
11	the facility or home. The report must include:
12	(1) the name of the child;
13	(2) the date of the suspension or expulsion;
14	(3) the reason for the suspension or expulsion;
15	(4) the race of the child;
16	(5) the disability status of the child; and
17	(6) the child's wandering history.
18	SECTION 5. As soon as practicable after the effective date
19	of this Act, the executive commissioner of the Health and Human
20	Services Commission shall adopt the rules necessary to implement
21	the changes in law made by this Act.
22	SECTION 6. This Act takes effect September 1, 2019.
