1	AN ACT
2	relating to enrollment of certain retirees in and cost-sharing for
3	the Texas Public School Employees Group Insurance Program.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 1575.161, Insurance Code, is amended by
6	adding Subsections (b) and (c) to read as follows:
7	(b) Notwithstanding Subsection (a), the trustee by rule
8	shall provide one opportunity to reenroll in a health benefit plan
9	offered under the group program for an otherwise eligible retiree:
10	(1) who is eligible to enroll in Medicare;
11	(2) whose initial enrollment was voluntarily
12	terminated on or after January 1, 2017, and on or before December
13	31, 2018; and
14	(3) who opts to reenroll on or before December 31,
15	<u>2023.</u>
16	(c) Subsection (b) and this subsection expire September 1,
17	2024.
18	SECTION 2. Section 1575.202(a), Insurance Code, is amended
19	to read as follows:
20	(a) Each state fiscal year, the state shall contribute to
21	the fund an amount equal to a percentage [1.25 percent] of the
22	salary of each active employee as follows:
23	(1) for the 2020 and 2021 fiscal years, 2.25 percent;

(2) for the 2022 fiscal year, 2.5 percent;

- 1 (3) for the 2023 fiscal year, 2.75 percent;
- 2 (4) for the 2024 fiscal year, three percent;
- 3 (5) for the 2025 fiscal year, 3.25 percent;
- 4 (6) for the 2026 fiscal year, 3.5 percent;
- 5 (7) for the 2027 fiscal year, 3.75 percent;
- 6 (8) for the 2028 fiscal year, four percent; and
- 7 (9) for the 2029 fiscal year, and each subsequent
- 8 fiscal year, 4.25 percent.
- 9 SECTION 3. Section 1575.212, Insurance Code, is amended by
- 10 adding Subsection (c) to read as follows:
- 11 <u>(c)</u> The trustee may not increase the payments under
- 12 Subsection (a-1) for a biennium in which the legislature does not
- 13 increase annuities under Chapter 824, Government Code.
- SECTION 4. (a) Not later than November 1, 2019, the Teacher
- 15 Retirement System of Texas shall adopt rules necessary to implement
- 16 Section 1575.161(b), Insurance Code, as added by this Act.
- 17 (b) Rules adopted by the Teacher Retirement System of Texas
- 18 under Section 1575.161(b), Insurance Code, as added by this Act,
- 19 must apply to a retiree described by that subsection, regardless of
- 20 whether the termination of the retiree's initial enrollment
- 21 occurred before, on, or after the effective date of the rules or
- 22 this Act.
- 23 SECTION 5. This Act takes effect immediately if it receives
- 24 a vote of two-thirds of all the members elected to each house, as
- 25 provided by Section 39, Article III, Texas Constitution. If this
- 26 Act does not receive the vote necessary for immediate effect, this
- 27 Act takes effect September 1, 2019.
