22	Sec. 3976.0103. PURPOSE; LEGISLATIVE FINDINGS. (a) The
23	creation of the district is essential to accomplish the purposes of

- 2 chapter. By creating the district and in authorizing the city and
- 3 other political subdivisions to contract with the district, the
- 4 legislature has established a program to accomplish the public

- 6 (b) The creation of the district is necessary to promote,
- 7 develop, encourage, and maintain employment, commerce,

- 18 (a) The district is created to serve a public use and benefit.
- 19 (b) All land and other property included in the district
- 20 will benefit from the improvements and services to be provided by
- 21 the district under powers conferred by Sections 52 and 52-a,
- 22 Article III, and Section 59, Article XVI, Texas Constitution, and
- 23 other powers granted under this chapter.
- (c) The district is created to accomplish the purposes of a
- 25 <u>municipal management district as provided by general law and</u>
- 26 Sections 52 and 52-a, Article III, and Section 59, Article XVI,
- 27 Texas Constitution.

- 4 (b) The boundaries and field notes contained in Section 2 of
- 5 the Act enacting this chapter form a closure. A mistake in the

- 7 does not affect the district's:
- 8 (1) organization, existence, or validity;
- 9 (2) right to contract;
- 10 (3) authority to borrow money or issue bonds or other

- 13 <u>(4) right to impose or collect an assessment, or</u>

- 18 director shall file the director's oath or affirmation of office
- 19 with the district, and the district shall retain the oath or

- 22 affirmation with the secretary of the city.

- 7 September 1, 2019, the owner or owners of a majority of the assessed
- 8 value of the real property in the district according to the most
- 9 recent certified tax appraisal rolls for the county may submit a
- 10 petition to the commission requesting that the commission appoint
- 11 as initial directors the four persons named in the petition. The
- 12 commission shall appoint as initial directors the four persons

- 14 (b) The governing body of the city shall appoint one initial

- 16 (c) The initial directors shall determine by lot which three

- 20 SUBCHAPTER C. POWERS AND DUTIES
- Sec. 3976.0301. GENERAL POWERS AND DUTIES. The district

- Sec. 3976.0302. IMPROVEMENT PROJECTS AND SERVICES. The
- 25 district may provide, design, construct, acquire, improve,
- 26 relocate, operate, maintain, or finance an improvement project or
- 27 service using money available to the district, or contract with a

- 5 Sec. 3976.0303. LOCATION OF IMPROVEMENT PROJECT.
- 6 district improvement project may be located inside or outside of

- 8 Sec. 3976.0304. OWNERSHIP OF IMPROVEMENT PROJECTS. (a)
- 9 Before a district improvement project may be put into operation,
- 10 the district must transfer ownership of the project:
- 11 (1) if the project is a water and sewer improvement
- 12 project, to the Galveston County Water Control and Improvement
- 13 District No. 12; or
- 14 (2) if the project is not described by Subdivision
- 15 <u>(1), to the city.</u>
- 16 (b) The transfer of ownership is complete on the applicable
- 17 entity's acceptance of ownership.
- 18 Sec. 3976.0305. RETAIL WATER AND SEWER SERVICES PROHIBITED.
- 19 The district may not provide retail water or sewer services.
- Sec. 3976.0306. ADDING OR REMOVING TERRITORY. (a) Subject
- 21 to Subsection (b), the board may add or remove territory as provided
- 22 by Subchapter J, Chapter 49, Water Code.
- 23 (b) The district may add territory as described by
- 24 Subsection (a) only if the governing body of the city by ordinance
- 25 or resolution consents to the addition.
- Sec. 3976.0307. LIMITED EMINENT DOMAIN POWER. The district
- 27 may not exercise the power of eminent domain unless the governing

- 1 body of the city consents to the exercise.
- 2 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS; ASSESSMENTS
- 3 Sec. 3976.0401. DISBURSEMENTS AND TRANSFERS OF MONEY. The
- 4 board by resolution shall establish the number of directors'
- 5 signatures and the procedure required for a disbursement or
- 6 transfer of the district's money.
- 7 Sec. 3976.0402. MONEY USED FOR IMPROVEMENTS OR SERVICES.
- 8 The district may acquire, construct, or finance an improvement
- 9 project or service authorized by this chapter or Chapter 375, Local
- 10 Government Code, using any money available to the district.
- 11 Sec. 3976.0403. METHOD OF NOTICE FOR HEARING. The district
- 12 may mail the notice required by Section 375.115(c), Local
- 13 Government Code, by certified or first class United States mail.
- 14 The board shall determine the method of notice.
- Sec. 3976.0404. ASSESSMENTS; LIENS FOR ASSESSMENTS. (a)
- 16 The board by resolution may impose and collect an assessment for any
- 17 purpose authorized by this chapter in all or any part of the
- 18 district.
- 19 <u>(b) An assessment, a reassessment, or an assessment</u>
- 20 resulting from an addition to or correction of the assessment roll
- 21 by the district, penalties and interest on an assessment or
- 22 reassessment, an expense of collection, and reasonable attorney's
- 23 <u>fees incurred by the district are:</u>
- 24 (1) a first and prior lien against the property
- 25 assessed;
- 26 (2) superior to any other lien or claim other than a
- 27 lien or claim for county, school district, or municipal ad valorem

- 1 taxes; and
- 2 (3) the personal liability of and a charge against the
- 3 owners of the property even if the owners are not named in the
- 4 assessment proceedings.
- 5 (c) The lien is effective from the date of the board's
- 6 resolution imposing the assessment until the date the assessment is
- 7 paid. The board may enforce the lien in the same manner that the
- 8 board may enforce an ad valorem tax lien against real property.
- 9 (d) The board may make a correction to or deletion from the
- 10 assessment roll that does not increase the amount of assessment of
- 11 any parcel of land without providing notice and holding a hearing in
- 12 the manner required for additional assessments.
- (e) The district may not impose an assessment on a
- 14 municipality, county, or other political subdivision.
- Sec. 3976.0405. NOTICE OF ASSESSMENTS. Annually, the board
- 16 shall file with the secretary of the city written notice that
- 17 specifies the assessments the district will impose in the
- 18 district's next fiscal year in sufficient clarity to describe the
- 19 assessments for the operation and maintenance of the district and
- 20 the assessments for the payment of debt service of obligations
- 21 issued or incurred by the district.
- 22 <u>SUBCHAPTER E. TAXES AND BONDS</u>
- Sec. 3976.0501. BONDS AND OTHER OBLIGATIONS. (a) The
- 24 district may issue, by public or private sale, bonds, notes, or

- 26 assessments in the manner provided by Subchapter A, Chapter 372, or

- Sec. 3976.0502. TAXES FOR WATER, WASTEWATER, AND DRAINAGE
- 17 PURPOSES. Taxes the district imposes for water, wastewater, and
- 18 drainage facility construction, if any, are for the particular
- 19 benefit of the area inside the district, do not generally or
- 20 directly benefit the area inside the Galveston County Water Control
- 21 and Improvement District No. 12 as a whole, and do not duplicate a
- 22 tax imposed by the Galveston County Water Control and Improvement
- 23 <u>District No. 12.</u>
- 24 SUBCHAPTER F. DISSOLUTION
- Sec. 3976.0601. DISSOLUTION BY CITY ORDINANCE. (a) The
- 26 governing body of the city may dissolve the district by ordinance.
- 27 (b) The governing body of the city may not dissolve the

- 1 district until water, sanitary, sewer, and drainage improvements
- 2 and roads have been constructed to serve at least 90 percent of the

- 12 other revenue, other than revenue from ad valorem taxes, the city
- 13 shall succeed to the rights and obligations of the district
- 14 regarding enforcement and collection of the assessments or other
- 15 <u>revenue.</u>
- 16 (b) The city shall have and exercise all district powers to
- 17 enforce and collect the assessments or other revenue to pay:
- 18 (1) the bonds or other obligations when due and
- 19 payable according to their terms; or
- 20 (2) special revenue or assessment bonds or other
- 21 obligations issued by the city to refund the outstanding bonds or
- 22 obligations.
- Sec. 3976.0603. ASSUMPTION OF ASSETS AND LIABILITIES. (a)
- 24 After the city dissolves the district, the city assumes, subject to
- 25 the appropriation and availability of funds, the obligations of the
- 26 district, including any bonds or other debt payable from
- 27 assessments or other district revenue.

- 1 (b) If the city dissolves the district, the board shall
- 2 transfer ownership of all district property to the city.
- 3 <u>SUBCHAPTER G. SPECIAL BOND PROVISIONS</u>
- 4 Sec. 3976.0701. APPLICABILITY. This subchapter applies
- 5 only to bonds payable wholly or partly from revenue derived from
- 6 assessments on real property in the district.
- 7 Sec. 3976.0702. CONFLICT OF LAWS. In the event of a
- 8 conflict between this subchapter and any other law, this subchapter
- 9 <u>prevails</u>.
- 10 Sec. 3976.0703. WRITTEN AGREEMENT REGARDING SPECIAL
- 11 APPRAISALS. Before the district may issue bonds, the district and
- 12 any person to whom the board intends that proceeds of the bonds be
- 13 distributed, including the developer, another owner of land in the
- 14 district, and any entity acting as a lender to the developer or
- 15 other landowner for the purpose of a project relating to the
- 16 <u>district</u>, must enter into a written agreement that:
- 17 (1) waives for the term of the agreement the right to a
- 18 special appraisal with respect to taxation by the district under
- 19 Subchapters B, C, D, E, F, and H, Chapter 23, Tax Code; and
- 20 (2) remains in effect for 30 years and is binding on
- 21 the parties, on entities related to or affiliated with the parties,
- 22 <u>and on their successors and assignees.</u>
- Sec. 3976.0704. REQUIREMENTS FOR ADVERTISING BOND ISSUE.
- 24 The district may not advertise for an issuance of bonds until the
- 25 completion of at least 25 percent of the projected value of the
- 26 improvements, including houses and other buildings, that are liable
- 27 for district assessments and necessary to support the district

1 bonds. 2 Sec. 3976.0705. REQUIREMENTS FOR BOND ISSUE. The district 3 may not issue bonds until: 4 (1) the district submits to the commission: 5 (A) an engineer's report describing the project 6 for which the bonds will provide funding, including data, profiles, 7 maps, plans, and specifications related to the project; and (B) a cash flow analysis to determine the 8 projected rate of assessment, which includes the following 9 10 assumptions: (i) each ending balance for debt service in 11 12 the analysis is not less than 25 percent of the following year's 13 debt service requirement; 14 (ii) interest income is only shown on the 15 ending balance for debt service for the first two years; and 16 (iii) the projected rate of assessment is level or decreasing for the life of the bonds issued by the 17 18 district; 19 (2) the completion of at least 75 percent of the projected value of the improvements, including houses and other 20 21 buildings, that are liable for district assessments and necessary 22 to support the district bonds; and (3) the district has obtained an independent market 23

- 1 Sec. 3976.0706. REQUIREMENTS FOR COLLECTION OF REVENUE TO
- 2 PAY BONDS. The district may not collect an assessment to be used
- 3 for the payment of bonds until:
- 4 (1) the completion of at least 95 percent of the
- 5 underground water, wastewater, and drainage facilities financed
- 6 from bond proceeds that are necessary to serve the projected
- 7 build-out, as certified by the district's engineer;
- 8 (2) the district or other appropriate party has
- 9 secured the groundwater, surface water, and water discharge permits
- 10 that are necessary to secure capacity to support the projected
- 11 build-out;
- 12 (3) the completion of at least 95 percent of lift
- 13 station, water plant, and sewage treatment plant capacity
- 14 sufficient to serve the connections constructed in the project for
- 15 <u>a period of not less than 18 months</u>, as certified by the district's
- 16 engineer; and
- 17 (4) the completion of at least 95 percent of the
