12	(1) "Board" means the district's board of directors.
13	(2) "City" means the City of Kemah, Texas.

19	Sec. 3976.0102. CREATION AND NATURE OF DISTRICT. The
20	district is a special district created under Sections 52 and 52-a,
21	Article III, and Section 59, Article XVI, Texas Constitution.
22	Sec. 3976.0103. PURPOSE; LEGISLATIVE FINDINGS. (a) The
23	creation of the district is essential to accomplish the purposes of
2.4	Sections 52 and 52-a. Article III. and Section 59. Article XVI.

- 1 Texas Constitution, and other public purposes stated in this
- 2 chapter. By creating the district and in authorizing the city and
- 3 other political subdivisions to contract with the district, the
- 4 legislature has established a program to accomplish the public
- 5 purposes set out in Section 52-a, Article III, Texas Constitution.
- 6 (b) The creation of the district is necessary to promote,
- 7 develop, encourage, and maintain employment, commerce,
- 8 transportation, housing, tourism, recreation, the arts,
- 9 entertainment, economic development, safety, and the public
- 10 welfare in the district.
- 11 (c) This chapter and the creation of the district may not be
- 12 interpreted to relieve the city from providing the level of
- 13 services provided to the area in the district as of the effective
- 14 date of the Act enacting this chapter. The district is created to
- 15 supplement and not to supplant the city services provided in the
- 16 <u>district</u>.
- 17 Sec. 3976.0104. FINDINGS OF BENEFIT AND PUBLIC PURPOSE.
- 18 (a) The district is created to serve a public use and benefit.
- 19 (b) All land and other property included in the district
- 20 will benefit from the improvements and services to be provided by
- 21 the district under powers conferred by Sections 52 and 52-a,
- 22 Article III, and Section 59, Article XVI, Texas Constitution, and
- 23 other powers granted under this chapter.
- (c) The district is created to accomplish the purposes of a
- 25 <u>municipal management district as provided by general law and</u>
- 26 Sections 52 and 52-a, Article III, and Section 59, Article XVI,
- 27 Texas Constitution.

1 (d) The creation of the district is in the public interest 2 and is essential to: 3 (1) further the public purposes of developing and diversifying the economy of the state; 4 5 (2) eliminate unemployment and underemployment; (3) develop or expand transportation and commerce; and 6 7 (4) provide quality residential housing. 8 (e) The district will: 9 (1) promote the health, safety, and general welfare of residents, employers, potential employees, employees, visitors, 10 and consumers in the district, and of the public; 11 (2) provide needed funding for the district to 12 preserve, maintain, and enhance the economic health and vitality of 13 14 the district territory as a community and business center; and 15 (3) promote the health, safety, welfare, and enjoyment of the public by providing pedestrian ways and by landscaping and 16 17 developing certain areas in the district, which are necessary for the restoration, preservation, and enhancement of scenic beauty. 18 19 (f) Pedestrian ways along or across a street, whether at grade or above or below the surface, and street lighting, street 20 21 landscaping, parking, and street art objects are parts of and necessary components of a street and are considered to be a street 22 23 or road improvement. 24 (g) The district will not act as the agent

- 17 DISTRICTS LAW. Except as otherwise provided by this chapter,
- 18 Chapter 375, Local Government Code, applies to the district.
- 19 Sec. 3976.0107. CONSTRUCTION OF CHAPTER. This chapter
- 20 shall be liberally construed in conformity with the findings and
- 21 purposes stated in this chapter.
- Sec. 3976.0108. CONFLICTS OF LAW. This chapter prevails
- 23 over any provision of Chapter 375, Local Government Code, that is in
- 24 conflict or inconsistent with this chapter.
- Sec. 3976.0109. CONSENT OF MUNICIPALITY REQUIRED. The
- 26 board may not hold an election to authorize the issuance of bonds
- 27 until the governing body of the city by ordinance or resolution

- 6 <u>SUBCHAPTER B. BOARD OF DIRECTORS</u>
- 7 Sec. 3976.0201. GOVERNING BODY; TERMS. The district is
- 8 governed by a board of five directors who serve staggered terms of
- 9 four years, with two or three directors' terms expiring June 1 of
- 10 each odd-numbered year. One director is appointed by the city, and
- 11 four directors are appointed by the commission as provided by
- 12 Sections 3976.0202 and 3976.0203, respectively.
- 13 Sec. 3976.0202. APPOINTMENT AND REMOVAL OF DIRECTOR
- 14 APPOINTED BY CITY. (a) The governing body of the city shall
- 15 <u>appoint one director who must be:</u>
- 16 <u>(1) at least 18 years of age; and</u>
- 17 (2) a resident of the city.
- (b) At any time the governing body of the city may remove the
- 19 director appointed by the city and appoint a director to serve the
- 20 remainder of the removed director's term.
- Sec. 3976.0203. APPOINTMENT BY COMMISSION. (a) Before the
- 22 term of a director other than a director appointed under Section
- 23 3976.0202 expires, the board shall recommend to the commission the
- 24 appropriate number of persons to serve as successor directors. The
- 25 commission shall appoint as directors the persons recommended by
- 26 the board.
- 27 (b) A person recommended by the board under Subsection (a)

- 1 must be:
- 2 (1) at least 18 years of age;
- 4 (3) an owner of stock, whether beneficial or
- 5 otherwise, of a corporate owner of property in the district;
- 6 (4) an owner of a beneficial interest in a trust that
- 7 owns property in the district; or
- 8 <u>(5) an agent, employee, or tenant of a person</u>
- 9 described by Subdivision (2), (3), or (4).
- Sec. 3976.0204. VACANCY. (a) Except as provided by
- 11 Subsection (b), if a vacancy occurs on the board, the remaining
- 12 directors shall appoint a director for the remainder of the
- 13 unexpired term.
- 14 (b) If a vacancy occurs in the office of the director
- 15 appointed by the city, the city shall appoint a director for the
- 16 <u>remainder of the unexpired term.</u>
- 17 Sec. 3976.0205. DIRECTOR'S OATH OR AFFIRMATION. (a) A
- 18 director shall file the director's oath or affirmation of office
- 19 with the district, and the district shall retain the oath or
- 20 affirmation in the district records.
- 21 (b) A director shall file a copy of the director's oath or
- 22 affirmation with the secretary of the city.
- Sec. 3976.0206. OFFICERS. The board shall elect from among
- 24 the directors a chair, a vice chair, and a secretary. The offices
- 25 of chair and secretary may not be held by the same person.
- Sec. 3976.0207. COMPENSATION; EXPENSES. (a) The district
- 27 may compensate each director in an amount not to exceed \$150 for

- 1 each board meeting. The total amount of compensation a director may
- 2 receive each year may not exceed \$7,200.
- 3 (b) A director is entitled to reimbursement for necessary
- 4 and reasonable expenses incurred in carrying out the duties and
- 5 responsibilities of the board.
- 6 Sec. 3976.0208. INITIAL DIRECTORS. (a) On or after
- 7 September 1, 2019, the owner or owners of a majority of the assessed
- 8 value of the real property in the district according to the most
- 9 recent certified tax appraisal rolls for the county may submit a
- 10 petition to the commission requesting that the commission appoint
- 11 as initial directors the four persons named in the petition. The
- 12 commission shall appoint as initial directors the four persons
- 13 named in the petition.
- 14 (b) The governing body of the city shall appoint one initial
- 15 <u>director</u>.
- 16 (c) The initial directors shall determine by lot which three
- 17 positions expire June 1, 2021, and which two positions expire June
- 18 1, 2023.
- 19 (d) This section expires September 1, 2021.
- 20 SUBCHAPTER C. POWERS AND DUTIES
- Sec. 3976.0301. GENERAL POWERS AND DUTIES. The district
- 22 has the powers and duties necessary to accomplish the purposes for
- 23 which the district is created.
- Sec. 3976.0302. IMPROVEMENT PROJECTS AND SERVICES. The
- 25 district may provide, design, construct, acquire, improve,
- 26 relocate, operate, maintain, or finance an improvement project or
- 27 service using money available to the district, or contract with a

- 5 Sec. 3976.0303. LOCATION OF IMPROVEMENT PROJECT.
- 6 district improvement project may be located inside or outside of
- 7 the district.
- 8 Sec. 3976.0304. OWNERSHIP OF IMPROVEMENT PROJECTS. (a)
- 9 Before a district improvement project may be put into operation,
- 10 the district must transfer ownership of the project:
- 11 (1) if the project is a water and sewer improvement
- 12 project, to the Galveston County Water Control and Improvement
- 13 District No. 12; or
- 14 (2) if the project is not described by Subdivision
- 15 <u>(1), to the city.</u>
- 16 (b) The transfer of ownership is complete on the applicable
- 17 entity's acceptance of ownership.
- 18 Sec. 3976.0305. RETAIL WATER AND SEWER SERVICES PROHIBITED.
- 19 The district may not provide retail water or sewer services.
- Sec. 3976.0306. ADDING OR REMOVING TERRITORY. (a) Subject
- 21 to Subsection (b), the board may add or remove territory as provided
- 22 by Subchapter J, Chapter 49, Water Code.
- 23 (b) The district may add territory as described by
- 24 Subsection (a) only if the governing body of the city by ordinance
- 25 or resolution consents to the addition.
- Sec. 3976.0307. LIMITED EMINENT DOMAIN POWER. The district
- 27 may not exercise the power of eminent domain unless the governing

- 1 body of the city consents to the exercise.
- 2 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS; ASSESSMENTS
- 3 Sec. 3976.0401. DISBURSEMENTS AND TRANSFERS OF MONEY. The
- 4 board by resolution shall establish the number of directors'
- 5 signatures and the procedure required for a disbursement or
- 6 transfer of the district's money.
- 7 Sec. 3976.0402. MONEY USED FOR IMPROVEMENTS OR SERVICES.
- 8 The district may acquire, construct, or finance an improvement
- 9 project or service authorized by this chapter or Chapter 375, Local
- 10 Government Code, using any money available to the district.
- 11 Sec. 3976.0403. METHOD OF NOTICE FOR HEARING. The district
- 12 may mail the notice required by Section 375.115(c), Local
- 13 Government Code, by certified or first class United States mail.
- 14 The board shall determine the method of notice.
- Sec. 3976.0404. ASSESSMENTS; LIENS FOR ASSESSMENTS. (a)
- 16 The board by resolution may impose and collect an assessment for any
- 17 purpose authorized by this chapter in all or any part of the
- 18 district.
- 19 <u>(b) An assessment, a reassessment, or an assessment</u>
- 20 resulting from an addition to or correction of the assessment roll
- 21 by the district, penalties and interest on an assessment or
- 22 reassessment, an expense of collection, and reasonable attorney's
- 23 <u>fees incurred by the district are:</u>
- 24 (1) a first and prior lien against the property
- 25 assessed;
- 26 (2) superior to any other lien or claim other than a
- 27 lien or claim for county, school district, or municipal ad valorem

- 1 taxes; and
- 2 (3) the personal liability of and a charge against the
- 3 owners of the property even if the owners are not named in the
- 4 assessment proceedings.
- 5 (c) The lien is effective from the date of the board's
- 6 resolution imposing the assessment until the date the assessment is
- 7 paid. The board may enforce the lien in the same manner that the
- 8 board may enforce an ad valorem tax lien against real property.
- 9 (d) The board may make a correction to or deletion from the
- 10 assessment roll that does not increase the amount of assessment of
- 11 any parcel of land without providing notice and holding a hearing in
- 12 the manner required for additional assessments.
- (e) The district may not impose an assessment on a
- 14 municipality, county, or other political subdivision.
- Sec. 3976.0405. NOTICE OF ASSESSMENTS. Annually, the board
- 16 shall file with the secretary of the city written notice that
- 17 specifies the assessments the district will impose in the
- 18 district's next fiscal year in sufficient clarity to describe the
- 19 assessments for the operation and maintenance of the district and
- 20 the assessments for the payment of debt service of obligations
- 21 issued or incurred by the district.
- 22 <u>SUBCHAPTER E. TAXES AND BONDS</u>
- Sec. 3976.0501. BONDS AND OTHER OBLIGATIONS. (a) The
- 24 district may issue, by public or private sale, bonds, notes, or
- 25 other obligations payable wholly or partly from ad valorem taxes or
- 26 assessments in the manner provided by Subchapter A, Chapter 372, or
- 27 Subchapter J, Chapter 375, Local Government Code. Sections

- 1 375.207(a) and (b), Local Government Code, do not apply to the
- 2 district.
- 3 (b) In exercising the district's borrowing power, the
- 4 district may issue a bond or other obligation in the form of a bond,
- 5 note, certificate of participation or other instrument evidencing a
- 6 proportionate interest in payments to be made by the district, or
- 7 other type of obligation.
- 8 (c) In addition to the sources of money described by
- 9 Subchapter A, Chapter 372, and Subchapter J, Chapter 375, Local
- 10 Government Code, district bonds may be secured and made payable
- 11 wholly or partly by a pledge of any part of the money the district
- 12 receives from improvement revenue or from any other source.
- 13 (d) Not later than the 30th day before the date the district
- 14 holds a bond sale, the district shall provide the governing body of
- 15 the city written notice of the sale.
- 16 Sec. 3976.0502. TAXES FOR WATER, WASTEWATER, AND DRAINAGE
- 17 PURPOSES. Taxes the district imposes for water, wastewater, and
- 18 drainage facility construction, if any, are for the particular
- 19 benefit of the area inside the district, do not generally or
- 20 <u>directly benefit the area inside the Galveston County Water Control</u>
- 21 and Improvement District No. 12 as a whole, and do not duplicate a
- 22 tax imposed by the Galveston County Water Control and Improvement
- 23 <u>District No. 12.</u>
- SUBCHAPTER F. DISSOLUTION
- Sec. 3976.0601. DISSOLUTION BY CITY ORDINANCE. (a) The
- 26 governing body of the city may dissolve the district by ordinance.
- 27 (b) The governing body of the city may not dissolve the

- 1 district until water, sanitary, sewer, and drainage improvements
- 2 and roads have been constructed to serve at least 90 percent of the
- 3 developable territory of the district.
- 4 (c) Until the district is dissolved, the district is
- 5 responsible for all bonds and other obligations of the district.
- 6 (d) The board may not dissolve the district under Subchapter
- 7 M, Chapter 375, Local Government Code, unless the board obtains the
- 8 written consent of the city.
- 9 Sec. 3976.0602. COLLECTION OF ASSESSMENTS AND OTHER
- 10 REVENUE. (a) If the dissolved district has bonds or other
- 11 obligations outstanding secured by and payable from assessments or
- 12 other revenue, other than revenue from ad valorem taxes, the city
- 13 shall succeed to the rights and obligations of the district
- 14 regarding enforcement and collection of the assessments or other
- 15 <u>revenue.</u>
- 16 (b) The city shall have and exercise all district powers to
- 17 enforce and collect the assessments or other revenue to pay:
- 18 (1) the bonds or other obligations when due and
- 19 payable according to their terms; or
- 20 (2) special revenue or assessment bonds or other
- 21 obligations issued by the city to refund the outstanding bonds or
- 22 obligations.
- Sec. 3976.0603. ASSUMPTION OF ASSETS AND LIABILITIES. (a)
- 24 After the city dissolves the district, the city assumes, subject to
- 25 the appropriation and availability of funds, the obligations of the
- 26 district, including any bonds or other debt payable from
- 27 assessments or other district revenue.

1 (b) If the city dissolves the district, the board shall

- 2 transfer ownership of all district property to the city.
