- 2 Sec. 8078.0104. CONSENT OF MUNICIPALITY REQUIRED. The
- 3 temporary directors may not hold an election under Section

- 5 extraterritorial jurisdiction the district is located has
- 6 consented by ordinance or resolution to the creation of the
- 7 district and to the inclusion of land in the district.
- 8 Sec. 8078.0105. FINDINGS OF PUBLIC PURPOSE AND BENEFIT.
- 9 (a) The district is created to serve a public purpose and benefit.
- 10 (b) The district is created to accomplish the purposes of:

- 12 general law and Section 59, Article XVI, Texas Constitution; and
- 13 (2) Section 52, Article III, Texas Constitution, that
- 14 relate to the construction, acquisition, improvement, operation,

- 16 improvements, including storm drainage, in aid of those roads.
- 17 Sec. 8078.0106. INITIAL DISTRICT TERRITORY. (a) The
- 18 district is initially composed of the territory described by
- 19 Section 2 of the Act enacting this chapter.
- 20 (b) The boundaries and field notes contained in Section 2 of
- 21 the Act enacting this chapter form a closure. A mistake made in the
- 22 field notes or in copying the field notes in the legislative process

(a) On or after September 1, 2019, the owner or owners of a majority of the assessed 9 value of the real property in the district may submit a petition to 10 the commission requesting that the commission appoint as temporary 11 12 directors the five persons named in the petition. The commission shall appoint as temporary directors the five persons named in the 13 14 petition. 15 (b) Temporary directors serve until the earlier of: 16 (1) the date permanent directors are elected under 17 Section 8078.0103; or 18 (2) September 1, 2023. (c) If permanent directors have not been elected under 19 Section 8078.0103 and the terms of the temporary directors have 20 expired, successor temporary directors shall be appointed or 21 reappointed as provided by Subsection (d) to serve terms that 22 23 expire on the earlier of: 24 (1) the date permanent directors are elected under 25 Section 8078.0103; or 26 (2) the fourth anniversary of the date of the

- 8 SUBCHAPTER C. POWERS AND DUTIES
- 9 Sec. 8078.0301. GENERAL POWERS AND DUTIES. The district
- 10 has the powers and duties necessary to accomplish the purposes for
- 11 which the district is created.
- 12 Sec. 8078.0302. MUNICIPAL UTILITY DISTRICT POWERS AND
- 13 DUTIES. The district has the powers and duties provided by the
- 14 general law of this state, including Chapters 49 and 54, Water Code,
- 15 applicable to municipal utility districts created under Section 59,
- 16 Article XVI, Texas Constitution.
- 17 Sec. 8078.0303. AUTHORITY FOR ROAD PROJECTS. Under Section
- 18 52, Article III, Texas Constitution, the district may design,
- 19 acquire, construct, finance, issue bonds for, improve, operate,
- 20 maintain, and convey to this state, a county, or a municipality for
- 21 operation and maintenance macadamized, graveled, or paved roads, or

- 13 consents to the creation of the district or to the inclusion of land
- 14 in the district.
- Sec. 8078.0306. DIVISION OF DISTRICT. (a) The district may
- 16 be divided into two or more new districts only if the district:
- 17 (1) has no outstanding bonded debt; and
- 18 (2) is not imposing ad valorem taxes.
- 19 (b) This chapter applies to any new district created by the
- 20 division of the district, and a new district has all the powers and

- 25 (b) The board shall determine the tax rate. The rate may not

- Sec. 8078.0403. CONTRACT TAXES. (a) In accordance with

- 1 Section 49.108, Water Code, the district may impose a tax other than
- 2 an operation and maintenance tax and use the revenue derived from
- 3 the tax to make payments under a contract after the provisions of
- 4 the contract have been approved by a majority of the district voters
- 5 voting at an election held for that purpose.
- 6 (b) A contract approved by the district voters may contain a
- 7 provision stating that the contract may be modified or amended by
- 8 the board without further voter approval.
- 9 SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS

- 19 direct ad valorem tax, without limit as to rate or amount, while all
- 20 or part of the bonds are outstanding as required and in the manner
- 21 provided by Sections 54.601 and 54.602, Water Code.
- Sec. 8078.0503. BONDS FOR ROAD PROJECTS. At the time of
- 23 issuance, the total principal amount of bonds or other obligations
- 24 issued or incurred to finance road projects and payable from ad
- 25 valorem taxes may not exceed one-fourth of the assessed value of the
- 26 real property in the district.
