## A BILL TO BE ENTITLED AN ACT

relating to the creation of the Montgomery County Municipal Utility 1-18 1-19 District No. 174; granting a limited power of eminent domain; providing authority to issue bonds; providing authority to impose 1-20 assessments, fees, and taxes. 1-21 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Subtitle F, Title 6, Special District Local Laws 1-22 1**-**23 Code, is amended by adding Chapter 8066 to read as follows: 1-24 1-25 CHAPTER 8066. MONTGOMERY COUNTY MUNICIPAL UTILITY DISTRICT NO. 174 SUBCHAPTER A. GENERAL PROVISIONS 8066.0101. DEFINITIONS. In this chapter: (1) "Board" means the district's board of directors. 1-26 1-27 Sec. 1-28 "Commission" means the Texas Commission 1-29 (2) on 1-30 Environmental Quality. "Director" means a board member. "District" means the Montgomery County Municipal 1-31 (3) 1-32 (4)1-33 Utility District No. 174. Sec. 8066.0102. NATURE OF DISTRICT. 1-34 The district is а municipal utility district created under Section 59, Article XVI, 1-35 Texas Constitution. Sec. 8066.0103. 1-36 1-37 CONFIRMATION AND DIRECTOR ELECTION 1-38 The temporary directors shall hold an election to REQUIRED. 1-39 confirm the creation of the district and to elect five permanent directors as provided by Section 49.102, Water Code. Sec. 8066.0104. CONSENT OF MUNICIPALITY REQUIRED. The temporary directors may not hold an election under Section 8066.0103 until each municipality in whose corporate limits or 1 - 401-41 1-42 1-43 extraterritorial jurisdiction the district is located 1-44 has 1-45 consented by ordinance or resolution to the creation of the district and to the inclusion of land in the district. 1-46 Sec. 8066.0105. FINDINGS OF PUBLIC PURPOSE AND BENEFIT The district is created to serve a public purpose and benefit. 1-47 BENEFIT. 1-48 (a) 1-49 The district is created to accomplish the purposes of: (b) 1-50 (1) a municipal utility district as provided by general law and Section 59, Article XVI, Texas Constitution; and (2) Section 52, Article III, Texas Constitution, that relate to the construction, acquisition, improvement, operation, 1-51 1-52 1-53 or maintenance of macadamized, graveled, or paved roads, 1-54 or improvements, including storm drainage, in aid of those roads. 1-55 1-56 Sec. 8066.0106. INITIAL DISTRICT TERRITORY. (a) The district is initially composed of the territory described Section 2 of the Act enacting this chapter. 1-57 by 1-58 (b) The boundaries and field notes contained in Section 2 of 1-59 the Act enacting this chapter form a closure. A mistake made in the 1-60 field notes or in copying the field notes in the legislative process 1-61

H.B. No. 4687 does not affect the district's: 2-1 organization, existence, or validity; right to issue any type of bond for the purposes 2-2 (1)2-3 (2) 2-4 for which the district is created or to pay the principal of and 2**-**5 2**-**6 interest on a bond; (3) right to impose a tax; or 2-7 legality or operation. (a) A 2-53 2-54 2-55 2-56 2-57 project must meet all applicable construction standards, road zoning and subdivision requirements, and regulations of each 2-58 2-59 municipality in whose corporate limits or extraterritorial jurisdiction the road project is located. (b) If a road project is not located in the corporate limits 2-60 2-61 2-62 extraterritorial jurisdiction of a municipality, the road or 2-63 project must meet all applicable construction standards, subdivision requirements, and regulations of each county in which 2-64 the road project is located. (a) If this Act does not receive a two-thirds 5-45 vote of all the members elected to each house, Subchapter C, Chapter 8066, Special District Local Laws Code, as added by Section 1 of 5-46 5-47 this Act, is amended by adding Section 8066.0306 to read as follows: 5-48 Sec. 8066.0306. NO EMINENT DOMAIN POWER. The district may 5-49

not exercise the power of eminent domain. (b) This section is not intended to be an expression of a legislative interpretation of the requirements of Section 17(c), 5-50 5-51 5-52 Article I, Texas Constitution.

5-53 SECTION 5. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this 5-54 5-55 5-56 5-57 Act takes effect September 1, 2019.
