1-17 relating to the territory of the Sutton County Underground Water
1-18 Conservation District.

1-19 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-20 SECTION 1. Section 8886.051, Special District Local Laws
1-21 Code, is amended to read as follows:

1-22 Sec. 8886.051. DISTRICT TERRITORY. The boundaries of the
1-23 district are coextensive with the boundaries of ~~[is composed of the~~
1-24 ~~territory in] Sutton County, [other than the territory in Sections~~
1-25 ~~60, 67, and 90, Block No. A, HE&WTRyCoSurvey, Sutton County,]~~
1-26 unless the district's territory has been modified under:

1-27 (1) Section 8886.052 or 8886.053 of this chapter or
1-28 their predecessor statutes, former Section 11 or 14, Chapter 377,
1-29 Acts of the 69th Legislature, Regular Session, 1985; or

1-30 (2) other law.

1-31 SECTION 2. (a) The legal notice of the intention to
1-32 introduce this Act, setting forth the general substance of this
1-33 Act, has been published as provided by law, and the notice and a
1-34 copy of this Act have been furnished to all persons, agencies,
1-35 officials, or entities to which they are required to be furnished
1-36 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
1-37 Government Code.

1-38 (b) The governor, one of the required recipients, has
1-39 submitted the notice and Act to the Texas Commission on
1-40 Environmental Quality.

1-41 (c) The Texas Commission on Environmental Quality has filed
1-42 its recommendations relating to this Act with the governor, the
1-43 lieutenant governor, and the speaker of the house of
1-44 representatives within the required time.

1-45 (d) All requirements of the constitution and laws of this
1-46 state and the rules and procedures of the legislature with respect
1-47 to the notice, introduction, and passage of this Act are fulfilled
1-48 and accomplished.

1-49 SECTION 3. This Act takes effect September 1, 2019.
