- 4 the effective date of the Act enacting this section, the owner or

- 7 Bend County nominating the five persons named in the petition as
- 8 initial voting directors.
- 9 (b) The governing body of Fort Bend County may reject the

- 12 governing body rejects a nomination, the owner or owners who
- 13 submitted the petition under Subsection (a) shall submit a new

- 7 the defined area or designated property.
- 8 Sec. 3921.256. ADDITION OR EXCLUSION OF LAND IN DEFINED
