FINDINGS OF PUBLIC PURPOSE AND BENEFIT. 8 (a) The district is created to serve a public purpose and benefit. 9 (b) The district is created to accomplish the purposes of a municipal utility district as provided by general law and Section 10 59, Article XVI, Texas Constitution. 11 Sec. 7958.0106. INITIAL DISTRICT TERRITORY. 12 (a) The district is initially composed of the territory described by 13 14 Section 2 of the Act enacting this chapter. (b) The boundaries and field notes contained in Section 2 of 15 the Act enacting this chapter form a closure. A mistake made in the 16 17 field notes or in copying the field notes in the legislative process does not affect the district's: 18 19 (1) organization, existence, or validity; (2) right to issue any type of bond for the purposes 20 for which the district is created or to pay the principal of and 21 22 interest on a bond;

- 5 Sec. 7958.0301. GENERAL POWERS AND DUTIES. The district
- 6 has the powers and duties necessary to accomplish the purposes for
- 7 which the district is created.
- 8 Sec. 7958.0302. MUNICIPAL UTILITY DISTRICT POWERS AND
- 9 DUTIES. The district has the powers and duties provided by the
- 10 general law of this state, including Chapters 49 and 54, Water Code,

- 13 Sec. 7958.0303. COMPLIANCE WITH MUNICIPAL CONSENT

- 25 Road);
- 26 THENCE Northeasterly with the centerline of County Road 192 to its
- 27 intersection with the centerline of County Road 193 (Taylor Road);

- 1 THENCE Northwesterly with the centerline of County Road 193 to its
- 2 intersection with the centerline of State Highway No. 155;
- 3 THENCE Northeasterly with the centerline of State Highway No. 155
- 4 to the place of beginning containing 21,118 acres of land, plus or

- 6 SECTION 3. (a) The legal notice of the intention to
- 7 introduce this Act, setting forth the general substance of this
- 8 Act, has been published as provided by law, and the notice and a
- 9 copy of this Act have been furnished to all persons, agencies,
- 10 officials, or entities to which they are required to be furnished
- 11 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 12 Government Code.
- 13 (b) The governor, one of the required recipients, has
- 14 submitted the notice and Act to the Texas Commission on
- 15 Environmental Quality.
- 16 (c) The Texas Commission on Environmental Quality has filed
- 17 its recommendations relating to this Act with the governor, the
- 18 lieutenant governor, and the speaker of the house of
- 19 representatives within the required time.
- 20 (d) All requirements of the constitution and laws of this
- 21 state and the rules and procedures of the legislature with respect
- 22 to the notice, introduction, and passage of this Act are fulfilled
- 23 and accomplished.
- SECTION 4. (a) If this Act does not receive a two-thirds
- 25 vote of all the members elected to each house, Subchapter C, Chapter
- 26 7958, Special District Local Laws Code, as added by Section 1 of
- 27 this Act, is amended by adding Section 7958.0304 to read as follows:

- 1 Sec. 7958.0304. NO EMINENT DOMAIN POWER. The district may
- 2 not exercise the power of eminent domain.
- 3 (b) This section is not intended to be an expression of a
- 4 legislative interpretation of the requirements of Section 17(c),
- 5 Article I, Texas Constitution.
- 6 SECTION 5. This Act takes effect immediately if it receives
- 7 a vote of two-thirds of all the members elected to each house, as
- 8 provided by Section 39, Article III, Texas Constitution. If this
- 9 Act does not receive the vote necessary for immediate effect, this
- 10 Act takes effect September 1, 2019.
