- 13 in Dayton, rising to the rank of sergeant and serving as assistant
- 14 chief; he later worked for the Hedwig Village Police Department,
- 15 and starting in 1994, he was an officer with the Spring Branch
- 16 Independent School District for 12 years, retiring in 2006 as
- 17 assistant chief; and
- 18 WHEREAS, Shortly after settling in Camp County,
- 19 Mr. Cortelyou accepted the position of chief deputy in the county
- 20 sheriff's office, and in 2008, he was appointed to fill a vacancy as
- 21 county constable; he went on to be elected to three more terms, and
- 22 during his exemplary tenure, he served as the county's emergency
- 23 management coordinator and IT manager and drafted many grant
- 24 applications to benefit local law enforcement agencies; and
