HOUSE CONCURRENT RESOLUTION

1 WHEREAS, Family and friends are mourning the loss of Philip 2 Wayne James of Arlington, who passed away on February 2, 2019, at 3 the age of 84; and

WHEREAS, Wayne James was born on September 11, 1934, to Dalton L. James and Minnie Caldwell James; his family initially resided in Dallas County before moving to Lubbock when he was nine years old; he completed his college studies at Texas Tech University, earning bachelor's and master's degrees; and

9 WHEREAS, In 1968, Mr. James had the good fortune to meet 10 Peggy Welling, and they spent a memorable first date at the State 11 Fair of Texas; the couple exchanged vows in 1971 and shared a 12 rewarding marriage that spanned nearly five decades; and

13 WHEREAS, Shortly after receiving his undergraduate degree, 14 Mr. James embarked on his career in association management by becoming the executive director of the Texas Tech Ex-Students 15 16 Association and its affiliate groups, a position he held for 21 years; he relocated to Arlington in 1978 and began focusing on trade 17 18 organizations related to such businesses as farm equipment sales and meat packing; in 1985, he became executive director of the Texas 19 Lathing and Plastering Contractors Association, and he later took 20 21 on related duties for the National Association of Manufacturers; he 22 retired from full-time employment in 2006 but continued to be 23 active on a part-time basis for another six years; and

24 WHEREAS, Mr. James garnered a number of important honors in

1 the course of his career, including the Texas Distinguished 2 Executive Award, the Construction Industry Lifetime Leadership 3 Award, and the Texas Tech University Alumni Association 4 Distinguished Executive Award; and

5 WHEREAS, An active member of his community, Mr. James served 6 on the boards of the Arlington Public Library and its foundation and 7 on several committees; in his leisure time, he enjoyed researching 8 his family's genealogy and taking classes in the Tarrant County 9 College Senior Education Program; and

10 WHEREAS, Wayne James lived a life that was rich in personal 11 and professional achievements, and he will forever be a source of 12 inspiration to those he leaves behind; now, therefore, be it

13 RESOLVED, That the 86th Legislature of the State of Texas 14 hereby pay tribute to the memory of Philip Wayne James and extend 15 heartfelt sympathy to his family and many friends; and, be it 16 further

17 RESOLVED, That an official copy of this resolution be 18 prepared for his family and that when the Texas House of 19 Representatives and Senate adjourn this day, they do so in memory of 20 Wayne James.
