CONCURRENT RESOLUTION

1 WHEREAS, The State of Texas lost a much-admired lawmaker and 2 friend to many with the death of former House Speaker Pro Tempore 3 D. R. "Tom" Uher of Bay City on March 9, 2019, at the age of 81; and WHEREAS, In 1967, Representative Uher won a special election 4 5 to the house on his 30th birthday, December 16; his constituents in Matagorda, Wharton, and Brazoria Counties would reelect him 17 6 7 times, and he served as speaker pro tempore in the 73rd through 77th Legislatures; over the course of more than three decades in office, 8 9 he chaired a number of committees, among them State Affairs and Redistricting, and he served on many others as well, such as the 10 11 Education, Higher Education, and Ways and Means Committees; and 12 WHEREAS, Representative Uher took special pride in the passage of a bill he authored that allowed MD Anderson Cancer Center 13 14 patients access to care without referrals; charming and collegial, he earned the affection of all his colleagues; he commonly ended 15 16 conversations by commending others as "a great American," and he himself became fondly known as "the Great American"; after leaving 17 the house in 2003, he continued to share his wisdom and experience 18 as a mentor to his fellow elected officials, including Speaker 19 20 Dennis Bonnen; and 21 WHEREAS, The son of Alfonso A. Uher and May Bittick Uher, Tom 22 Uher was born in Bay City in 1937, and he grew up with the 23 companionship of three siblings, Doris, Myrna, and LaVerne; he

- 8 more than five and a half decades with his wife, Ann Hagaman Uher,
- 9 and they welcomed into their family two daughters, Christi and
- 10 Catherine, and a son, Robert, as well as two grandsons, Christopher
- 11 and the late Noah Carl Uher; and
- 12 WHEREAS, Through his steadfast dedication to public service,
- 13 Tom Uher made a lasting, positive impact in the lives of innumerable
- 14 Texans, and his contributions will be remembered for years to come;

- 17 hereby pay tribute to the memory of the Honorable D. R. "Tom" Uher
