## A JOINT RESOLUTION

- 1 proposing a constitutional amendment regarding the dedication by
- 2 general law of revenue of or money received by this state and money
- 3 held in or deposited to an account or fund inside or outside the
- 4 state treasury and the authorized expenditure or appropriation of
- 5 revenue or money dedicated by general law.
- 6 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. Article VIII, Texas Constitution, is amended by
- 8 adding Section 25 to read as follows:
- 9 <u>Sec. 25.</u> (a) The legislature by general law may dedicate
- 10 to one or more particular purposes the appropriation or expenditure
- 11 of:
- 12 (1) revenue of, or money received by, this state from
- 13 one or more particular sources; or
- 14 (2) money held in or deposited to an identified
- 15 account or fund inside or outside the state treasury.
- 16 (b) Subsection (a) of this section does not authorize a
- 17 dedication by general law of revenue or money otherwise dedicated
- 18 by this constitution in a manner that is inconsistent with that
- 19 <u>constitutional dedication.</u>
- 20 <u>(c)</u> Revenue or money the appropriation or expenditure of
- 21 which is dedicated by general law to a purpose or purposes as
- 22 described by Subsection (a) of this section may not be appropriated
- 23 or expended for any purpose other than the dedicated purpose or
- 24 purposes, except as authorized by a subsequently adopted general

- 1 <u>law that:</u>
- 2 <u>(1) expressly amends or repeals the general law under</u>
- 3 which the revenue or money was dedicated; and
- 4 (2) is adopted by a record vote of two-thirds of the
- 5 membership of both houses of the legislature.
- 6 SECTION 2. The following temporary provision is added to
- 7 the Texas Constitution:
- 8 <u>TEMPORARY PROVISION</u>. (a) This temporary provision applies
- 9 to the constitutional amendment proposed by the 86th Legislature,
- 10 Regular Session, 2019, regarding the dedication by general law of
- 11 revenue of or money received by this state and money held in or
- 12 deposited to an account or fund inside or outside the state treasury
- 13 and the authorized expenditure or appropriation of revenue or money
- 14 dedicated by general law.
- 15 (b) Section 25, Article VIII, of this constitution takes
- 16 effect September 1, 2021, and applies only to appropriations
- 17 authorized for or expenditures during a state fiscal year beginning
- 18 on or after that date.
- (c) This temporary provision expires January 1, 2022.
- 20 SECTION 3. This proposed constitutional amendment shall be
- 21 submitted to the voters at an election to be held November 5, 2019.
- 22 The ballot shall be printed to provide for voting for or against the
- 23 proposition: "The constitutional amendment regarding the
- 24 dedication by general law of revenue of or money received by this
- 25 state and money held in or deposited to an account or fund inside or
- 26 outside the state treasury and the authorized expenditure or
- 27 appropriation of revenue or money dedicated by general law."
