## RESOLUTION

- BE IT RESOLVED, by the House of Representatives of the 86th
- 2 Legislature of the State of Texas, That, in accordance with
- 3 Sections 9(b) and 11, Article III, Texas Constitution, and the laws
- 4 of the State of Texas, the House of Representatives of the 86th
- 5 Legislature shall proceed to elect a speaker of the house from its
- 6 own membership as follows:
- 7 SECTION 1. NOMINATIONS. (a) The secretary of state shall
- 8 call for nominations from the floor for the election of speaker of
- 9 the house of representatives and shall recognize each member who
- 10 desires to make a nomination. The order in which members shall
- 11 proceed to make a nomination shall be determined by lot.
- 12 (b) Each member recognized for this purpose shall
- 13 immediately advance to the microphone at the reading clerk's desk
- 14 and make the nomination in a nominating speech not to exceed five
- 15 minutes in length.
- 16 (c) After all nominations have been made, the secretary of
- 17 state shall declare nominations to be closed.
- 18 (d) The secretary of state shall recognize at any time a
- 19 member whose name has been placed in nomination for the purpose of
- 20 withdrawing as a nominee. A member who withdraws is not considered
- 21 a nominee.
- 22 SECTION 2. SECONDS. (a) A person is not considered a
- 23 nominee unless the nomination is seconded by at least one member.
- 24 (b) One seconding speech shall be allowed for each

- 1 nomination in the order in which nominations were made, then other
- 2 seconding speeches shall be allowed in rotation in the same order.
- 3 (c) No more than five seconding speeches shall be allowed
- 4 for each nominee.
- 5 (d) A seconding speech may not exceed three minutes in
- 6 length.
- 7 SECTION 3. MOTION TO ELECT BY ACCLAMATION. If, after the
- 8 close of all seconding speeches only one member's name remains in
- 9 nomination for election to speaker of the house of representatives,
- 10 the secretary of state shall recognize a motion to elect that member
- 11 as speaker by acclamation.
- 12 SECTION 4. OATH. (a) After the election, the secretary of
- 13 state shall:
- 14 (1) appoint a committee of members to escort the
- 15 speaker-elect to the speaker's rostrum for the purpose of taking
- 16 the constitutional oath or affirmation of office by the
- 17 speaker-elect; and
- 18 (2) direct the administration of the oath or
- 19 affirmation of office to the speaker-elect.
- 20 (b) The speaker shall take the chair immediately after
- 21 taking the oath or affirmation of office.
