1 WHEREAS, Dr. DeVry C. Anderson of Austin is serving as
2 Physician of the Day at the State Capitol on January 15, 2019, and
3 his participation in this time-honored tradition is indeed
4 laudable; and

5 WHEREAS, A colonel in the United States Army, Dr. Anderson
6 has served since 2017 as vice president and deputy commander for
7 medical services at the Carl R. Darnall Army Medical Center at Fort
8 Hood; he first joined CRDAMC in 2014 as chair of the Deployment and
9 Operational Medicine Department and became vice president and
10 deputy commander of the Health Readiness Division the following
11 year; and

12 WHEREAS, Dr. Anderson graduated from the United States
13 Military Academy at West Point and Thomas Jefferson Medical
14 College, and he went on to complete an MBA at Norwich University
15 School of Business; over the course of his noteworthy career, he has
16 served in combat operations as a battalion surgeon and flight
17 surgeon, and he was brigade surgeon for the Warrior Transition
18 Brigade, regimental surgeon for the 3rd Armored Cavalry Regiment,
19 and Task Force Eagle surgeon during the Hurricane Katrina relief
20 effort; he also has private-sector experience as Texas regional
21 medical director for Next Care Urgent Care, and he operated an
22 independently owned urgent care clinic; and

23 WHEREAS, The author of numerous scholarly publications,
24 Dr. Anderson holds adjunct professorships in medicine at the

1 F. Edward Hébert School of Medicine, Uniformed Services University
2 of the Health Sciences, and Texas A&M Health Science Center College
3 of Medicine; in 2016, he was inducted into the Order of Military
4 Medical Merit, and his many honors include the Bronze Star, the Air
5 Medal, and the Combat Medical Badge; and

6 WHEREAS, Dr. Anderson has distinguished himself greatly
7 through his outstanding service to his country and his
8 accomplishments in the medical profession, and it is indeed a
9 pleasure to welcome him to the State Capitol; now, therefore, be it

10 RESOLVED, That the House of Representatives of the 86th Texas
11 Legislature hereby commend Dr. DeVry C. Anderson for his
12 participation in the Physician of the Day program and honor him for
13 his achievements; and, be it further

14 RESOLVED, That an official copy of this resolution be
15 prepared for Dr. Anderson as an expression of high regard by the
16 Texas House of Representatives.
