

R E S O L U T I O N

1 WHEREAS, Proud residents of Lucas are gathering at city hall
2 on February 19, 2019, to celebrate the 60th anniversary of the
3 founding of their community; and

4 WHEREAS, In 1888, a post office and general store were
5 established on the site of the future town by Gabriel Lucas, who was
6 later named the first postmaster, and the surrounding area came to
7 be known as Lucas; in the 20th century, residents decided to
8 incorporate the town, and O. E. Spurgin was delegated to present a
9 detailed survey and a petition with 31 signatures to a local judge,
10 who called an election; and

11 WHEREAS, Lucas was incorporated on February 19, 1959, and in
12 1967, the town took out a loan for a water system, with each
13 resident paying for water from the newly completed Lake Lavon dam;
14 twelve years later, the Public Utility Commission of Texas granted
15 the Town of Lucas the responsibility for providing water to its
16 citizens; and

17 WHEREAS, The Lucas fire and rescue service was established in
18 1973 by 18 volunteers, and today the city supports a modern fire
19 department with 15 career firefighters and 18 volunteers; and

20 WHEREAS, Now home to nearly 8,000 citizens, Lucas maintains
21 its family friendly and quiet country atmosphere, and its residents
22 may indeed take great pride in their history as they look forward to
23 a bright and prosperous future; now, therefore, be it

24 RESOLVED, That the House of Representatives of the 86th Texas
