1 WHEREAS, The League of United Latin American Citizens is 2 celebrating the 90th anniversary of its founding from February 17

to 23, 2019; and 3

WHEREAS, Established in Corpus Christi in 1929, LULAC drew 4 5

strength from the rise of the Texas-Mexican middle class and the

growing resistance to discrimination; it became 6

7 nationwide Mexican American civil rights organization, striving to

end political disenfranchisement, racial segregation, lack of 8

9 political representation, and jury exclusion; a multi-issue

organization from its inception, it also sought to address the 10

11 roots of poverty and promote economic progress; and

12 WHEREAS, LULAC organized poll tax drives and fought to

abolish these antidemocratic taxes; in the 1930s, it investigated

14 charges of discrimination by the Works Progress Administration, and

it later worked with the Federal Employment Practices Commission to 15

16 open up jobs for Mexican Americans in the defense industry; members

were engaged in Hernandez v. State of Texas, which secured for 17

Mexican Americans the right to serve on juries; moreover, they 18

fought for the appointment of Mexican Americans to important 19

20 federal and state positions and supported candidates for public

21 office; and

WHEREAS, Deeply committed to school desegregation, LULAC was 22

23 engaged in such pivotal court cases as Delgado v. Bastrop ISD, which

ended segregation in public schools; from its early years, the 24

- 2 1974, it created a national scholarship fund, as well as the LULAC
- National Educational Service Centers; members also participated in
- 4 a 1990 case seeking the allocation of a greater share of state funds
- 5 to South Texas colleges; along the way, LULAC played a role in the
- 6 formation of a number of important organizations, among them the
- 7 Mexican American Legal Defense and Educational Fund; and
- 8 WHEREAS, In recent years, LULAC has continued its efforts to
- 9 protect the civil rights of Latinos while expanding opportunities
- 10 in education, employment, economic advancement, and political
- 11 influence; its comprehensive suite of nationwide programs support
- 12 such worthy causes as affordable housing, health care access,
- 13 citizenship, and humanitarian relief; and
- 14 WHEREAS, Over the course of nine decades, LULAC has helped to
- 15 build a more just, equitable, and vibrant society, and its
- 16 contributions have improved the lives of countless Americans; now,
- 17 therefore, be it
- 18 RESOLVED, That the House of Representatives of the 86th Texas
- 19 Legislature hereby recognize February 17 to 23, 2019, as National
- 20 LULAC Week and extend to the members of the organization sincere
- 21 best wishes for the future.
