- 3 at the age of 87; and
- WHEREAS, The son of Louis and Nina Bronaugh, Louis Bronaugh
- 5 was born in Dallas on May 28, 1931, and he grew up with the
- 6 companionship of a brother, Bob; following his graduation from
- 7 Lamar High School, he answered his nation's call to duty and served
- 8 in the U.S. Navy during the Korean War; returning to civilian life,
- 9 he continued his education at Texas Tech University; and
- 10 WHEREAS, Mr. Bronaugh enjoyed the love and support of his
- 11 wife, Charda, and they shared a rewarding marriage that spanned
- 12 more than six decades; he took great pride in his children, Timothy,
- 13 Tina, Mike, and Belinda, and with the passing years, he had the
- 14 pleasure of seeing his family grow to include four grandchildren,
- 15 Christa, Alan, Rand, and Perrin, and three great-grandchildren,
- 16 Ava, Jason, and Timothy; and
- 17 WHEREAS, In the course of his career as an optician,
- 18 Mr. Bronaugh worked at The Eye Clinic in Lufkin, and in 1974, he and
- 19 his wife established Bronaugh Independent Opticians; deeply
- 20 devoted to the Lufkin community, he served on the city council and
- 21 further distinguished himself through an exceptional 18-year
- 22 tenure as mayor; and
- WHEREAS, Mr. Bronaugh also dedicated his time to a number of
- 24 area organizations, including the Angelina & Neches River

- 1 Authority; he was appointed to the agency's board of directors on
- 2 October 16, 2000, and was reappointed on April 12, 2012, to hold a
- 3 second term; he benefited the group through his service in several
- 4 officer positions, among them secretary-treasurer of the board, and
- 5 he was instrumental to the authority's success in managing the
- 6 quality, development, and conservation of water resources in the
- 7 Neches River Basin; and
- 8 WHEREAS, In recognition of his outstanding efforts,
- 9 Mr. Bronaugh received numerous honors over the years, including the
- 10 1986 Angelina Award from the Angelina County Chamber of Commerce
- 11 and the Silver Beaver Award and BSA Distinguished Citizen Good Turn
- 12 Award from the East Texas Area Council, Boy Scouts of America; and
- WHEREAS, The life of Louis Bronaugh stands as an inspiring
- 14 example of the good that one person can accomplish, and his
- 15 achievements will be remembered and admired for many years to come;
