- 16 Jack; and
- WHEREAS, In 1977, Jack Sims and his wife, LaRue, took over the
- 18 ranch, where they raised cattle, horses, and improved grasses;
- 19 their three children were Sharon, Harry, and Kyle, and in 1990,
- 20 Harry Sims and his wife, Sherry, became the owners and operators of
- 21 the Rockin' S; and
- WHEREAS, Over the years, Harry and Sherry Sims have added
- 23 more than 3,500 acres to their spread, and they continue to grow
- 24 cattle, horses, and improved grasses on the ranch's original

- 1 acreage, where the former ranch house is still used as a camp house
- 2 and guest quarters; the couple have two children, Juhree and Tye,
- 3 four grandchildren, Lauren, Chase, Savanna, and Kelton, and two
- 4 great-grandchildren, Jerry and Jack; and
- 5 WHEREAS, In preserving their property as a working ranch,
- 6 Harry and Sherry Sims are making their own contribution to their
- 7 family's legacy, and it is indeed fitting that they be honored for
- 8 their outstanding stewardship; now, therefore, be it

- 10 Legislature hereby congratulate Harry and Sherry Sims on the
- 11 induction of the Rockin' S Ranch into the Texas Department of
