1 WHEREAS, Robert and Linda Adam have given generously of their
2 time and resources to promote excellence in education in the
3 Cypress-Fairbanks community, and the outstanding contributions of
4 this esteemed couple indeed merit special recognition; and

5 WHEREAS, Bob Adam is a lifelong resident of the area and a
6 product of the Cypress-Fairbanks Independent School District,
7 where he played football and graduated from Cy-Fair High School; he
8 went on to attend Baylor University before establishing his law
9 practice; while a student at Baylor, he met his future wife, Linda,
10 with whom he has shared 57 years of marriage and raised three
11 daughters; and

12 WHEREAS, Mr. Adam's commitment to education is inspired in
13 part by his father, B. F. Adam, who served on the Cy-Fair ISD Board
14 of Trustees and had an elementary school named in his honor in 1972;
15 continuing that legacy, the younger Mr. Adam has been an active
16 member of the Cy-Fair Educational Foundation for 48 years, and at
17 its Diamond Jubilee in 2014, he was recognized as the
18 longest-serving trustee of the foundation and a key fund-raiser for
19 the B. F. Adam Golf Classic; he has also sat on numerous boards for
20 the Lone Star College System, the Richard Wallrath Educational
21 Foundation, and Cy-Fair Hospital, to name but a few organizations,
22 and has dedicated countless hours to such community groups as the
23 Cy-Fair Houston Chamber of Commerce and Cy-Fair ISD; recently, he
24 was presented with the Chairman's Award by the chamber; and

1 WHEREAS, Likewise an advocate for education, Mrs. Adam
2 taught at Spring Branch ISD before resuming her career at Cy-Fair
3 ISD, where she continued to volunteer after retiring from work to
4 devote more time to her grandchildren; over the years, she has made
5 a difference in the lives of countless students, and she has
6 partnered with her husband to help coordinate volunteers for the
7 B. F. Adam Golf Classic and to establish endowments totaling more
8 than \$1.1 million in scholarships for graduating Cy-Fair ISD
9 seniors; in addition to their many civic endeavors, the couple have
10 been valued congregants of several area Baptist churches; and

11 WHEREAS, Bob and Linda Adam's combined volunteer and
12 philanthropic efforts have strengthened their community and helped
13 make it an even better place in which to raise a family, and they
14 have created a legacy that will benefit young Texans for years to
15 come; now, therefore, be it

17 Legislature hereby honor Robert and Linda Adam for their
18 exceptional leadership and service in behalf of public education
