1 WHEREAS, The residents of Weatherford lost a courageous and
2 greatly admired public servant when Richard "Andy" Loller Jr. of
3 the Weatherford Fire Department died in the line of duty on June 10,
4 2018, at the age of 42; and

5 WHEREAS, Mr. Loller was killed while taking part in a
6 wildland deployment in the Davis Mountains as part of a 12-member
7 North Texas Strike Team that was working to contain the Scenic Loop
8 Complex Fires; and

9 WHEREAS, Andy Loller was born in Fort Worth on February 26,
10 1976, to Richard Loller and Yvonne Collins, and he grew up with the
11 companionship of a sister, Amber; he began his firefighting career
12 in 2002 with the Hudson Oaks Fire Department, and in 2013 he joined
13 the Weatherford Fire Department, where he worked on the A-Shift;
14 and

15 WHEREAS, A member of the International Association of
16 Firefighters Local No. 3823, this skilled first responder served
17 his community with tremendous dedication, and on his off-duty days,
18 he worked part-time for the Greenwood Rural Volunteer Fire
19 Department; and

20 WHEREAS, Mr. Loller cherished his family, which included his
21 wife, Debra Loller, and their children, Chelsea and Colby; an avid
22 outdoorsman, he enjoyed spending his free time hunting, shooting,
23 and fishing; in all his endeavors, he was sustained by his deep
24 faith; and

1 WHEREAS, Andy Loller selflessly devoted himself to
2 protecting the lives and property of his fellow Texans, and his
3 colleagues and loved ones will forever remember his valiant
4 sacrifice as well as the joy that he brought to all those who had the
5 good fortune to know him; now, therefore, be it

6 RESOLVED, That the House of Representatives of the 86th Texas
7 Legislature hereby pay tribute to the memory of Richard "Andy"
8 Loller Jr. and extend heartfelt condolences to the members of his
9 family: to his wife, Debra Loller; to his children, Chelsea and
10 Colby Robertson; to his grandson, Jaxson Ortega; to his mother,
11 Yvonne Collins; to his sister, Amber Pullin, and her husband, Cody;
12 to his nieces, Brooke Shirley and Katie Ann Pullin; to his nephew,
13 Corbitt Shirley; to his close friends, Seth and Lindsay Winburn,
14 and their daughter, Clara; and to his other friends, his fellow
15 firefighters, and all who mourn his passing; and, be it further

18 Representatives adjourns this day, it do so in memory of Andy
19 Loller.
