- 1 WHEREAS, For the past quarter century, the Austin LGBT
- 2 Chamber of Commerce has been a voice and an advocate for the
- 3 lesbian, gay, bisexual, and transgender business owners of Austin;
- 4 and
- 5 WHEREAS, Originally established in 1994 as the Stonewall
- 6 Chamber of Commerce, after the Stonewall demonstrations in New York
- 7 City in 1969, the chamber was renamed the Austin Gay and Lesbian
- 8 Chamber of Commerce in 1997; it became one of the founding members
- 9 of the National Gay and Lesbian Chamber of Commerce (NGLCC) in 2004,
- 10 and in 2017, it changed its name to the Austin LGBT Chamber of
- 11 Commerce, in recognition of the contributions of the bisexual and
- 12 transgender communities to the local economy; and
- WHEREAS, Over the years, the Austin chamber has grown in
- 14 membership and influence; milestones have included the publication
- 15 of its first magazine, Forward Austin, in 2007, its attainment of
- 16 300 members in 2009, and the first publication of its quarterly
- 17 magazine, the Agenda, in 2012; it received the Rising Star Chamber
- 18 of the Year Award from the NGLCC in 2013, and that same year, it was
- 19 named Best Shop-Local Portal in the Austin Chronicle's Best of
- 20 Austin poll; and
- 21 WHEREAS, In addition, the chamber has become a powerful force
- 22 for inclusion and diversity in the community; it sponsored its
- 23 first Pride Parade in Austin in 2001 and continued to host the
- 24 parade and festival until 2010, drawing more than 50,000

- 1 participants each year; on the first day of the 2013 SXSW
- 2 Interactive Festival, it organized the first #BigGay Kickoff Party,
- 3 attracting more than 1,500 attendees, and in 2015, it was
- 4 recognized with the Excellence in Community Impact Award from the
- 5 NGLCC; and
- 6 WHEREAS, Each June, the chamber hosts the Proud! Gala, an
- 7 annual business awards ceremony and scholarship fund-raiser for
- 8 LGBT students; over the past year, the chamber has launched an
- 9 Employee Resource Groups program and created an advocacy committee;
- 10 it is also one of the founding chambers of the Texas LGBT Chambers
- 11 of Commerce, a statewide advocacy group that is holding its first
- 12 legislative day at the State Capitol in 2019; and
- WHEREAS, By empowering LGBT businesses and their allies, the
- 14 Austin LGBT Chamber of Commerce is working to develop a supportive,
- 15 diverse, and prosperous environment throughout the Capital City;
- 16 now, therefore, be it
- 17 RESOLVED, That the House of Representatives of the 86th Texas
- 18 Legislature hereby honor the Austin LGBT Chamber of Commerce for
- 19 its first 25 years and extend to the chamber and its members sincere
- 20 best wishes for continued success; and, be it further
- 21 RESOLVED, That an official copy of this resolution be
- 22 prepared for the Austin LGBT Chamber of Commerce as an expression of
- 23 high regard by the Texas House of Representatives.
