- 1 WHEREAS, The World Boxing Council has served as a positive
- 2 international influence in the sport of boxing for more than half a
- 3 century; and
- 4 WHEREAS, One of four major entities that sanction world
- 5 championship boxing fights, the World Boxing Council was created on
- 6 February 14, 1963, in Mexico City; representatives from Argentina,
- 7 Brazil, Chile, England, France, Mexico, Panama, Peru, the
- 8 Philippines, the United States, and Venezuela were involved at the
- 9 time of its establishment, and the WBC is now affiliated with more
- 10 than 165 countries around the globe; over the years, the council has
- 11 introduced rules and procedures that have transformed the sport,
- 12 such as shortening title fights from 15 rounds to 12 and
- 13 implementing a range of regulations to make the sport safer and
- 14 fairer; and
- WHEREAS, The WBC was led for nearly four decades by Dr. Jose
- 16 Sulaimán Chagnón, who served as president from 1975 until his death
- 17 in 2014; his many achievements included expanding the council's
- 18 global reach and creating World Boxing Cares, a nonprofit
- 19 initiative in which boxing celebrities visit children at hospitals,
- 20 orphanages, and youth centers; and
- 21 WHEREAS, Since the passing of Dr. Sulaimán, the WBC has been
- 22 guided by his son, Mauricio Sulaimán, who had assisted his father
- 23 for many years and had served as executive secretary before
- 24 assuming his present roles as president and chief executive

- 1 officer; dedicated to boxing safety, Mauricio Sulaimán organized an
- 2 annual convention for the review and improvement of regulations;
- 3 moreover, the WBC continues to be active in community affairs by
- 4 supporting a range of charitable efforts; and
- 5 WHEREAS, Throughout its history, the WBC has excelled in its
- 6 mission of promoting the sport of boxing while serving as a unifying
- 7 force in the many nations in which it operates and among the diverse
- 8 array of athletes with whom it is affiliated; now, therefore, be it
- 9 RESOLVED, That the House of Representatives of the 86th Texas
- 10 Legislature hereby honor the contributions of the World Boxing
- 11 Council and extend to all those associated with the organization
- 12 sincere best wishes for the future; and, be it further
- 13 RESOLVED, That an official copy of this resolution be
- 14 prepared for the WBC as an expression of high regard by the Texas
- 15 House of Representatives.
