21 Stroke Support Group, and he was a former chair of the Laredo
22 Chamber of Commerce; he also mentored Texas A&M International
23 University students and provided them with real-world business

2 love and support of his wife, Lulu, with whom he shared 30 rewarding
3 years of marriage, and he was a devoted father to his children,
4 Brian and Lindsay; and

6 he leaves behind a record of service that his loved ones can
7 remember with pride; now, therefore, be it
