2 respected business leader with the passing of Jack Harold Albert on
3 February 3, 2018, at the age of 82; and

4 WHEREAS, Born in San Angelo on August 25, 1935, to Harold and
5 Nina McLaughlin Albert, Jack Albert grew up with the companionship
6 of his brother, Mike; after graduating from San Angelo High School,
7 he went on to attend Texas Technological College, where he earned a
8 bachelor's degree in geology; and

9 WHEREAS, Mr. Albert went to work for his family's small civil
10 contracting firm as a young man and soon took over its operation;
11 over the course of his 56-year tenure, it grew from a small family
12 business into a major heavy construction and materials company
13 known today as Reece Albert, Inc. and CSA Materials, Inc.;
14 Mr. Albert contributed to his professional community through his
15 involvement with the Associated General Contractors of Texas, which
16 he served as president, and he also held leadership positions with
17 the Associated General Contractors of America and the Texas Asphalt
18 Pavement Association, and numerous other groups; and

19 WHEREAS, An active member of the San Angelo community,
20 Mr. Albert served on boards for the city, the chamber of commerce,
21 and Angelo Community Hospital, and he participated in the San
22 Angelo Jaycees and the Kiwanis club; and

23 WHEREAS, In all his endeavors, Mr. Albert enjoyed the love
24 and support of his wife, Debbie Garnett Albert, and he took great

1 pride in his four children, Richard Lon, Stuart Todd, Kenneth Ross,
2 and Shauna L'Nea; and

3 WHEREAS, Deeply dedicated to his family, his profession, and
4 his community, Jack Albert earned the lasting admiration of all who
5 were privileged to know him; now, therefore, be it
