5 WHEREAS, A native of Marrero, Louisiana, Mr. Stiefvater moved to Texas with his family when he was 10, and he joined the 6 7 U.S. Air Force in August 1989; trained as a mechanic, he worked on KC-10 Extender tanker and cargo aircraft and B-52 Stratofortress 8 9 bombers at Barksdale Air Force Base in Louisiana, rising through the ranks from airman first class to staff sergeant; in July 1997, 10 11 he transferred to Tinker AFB to serve as an E-3/AWACS crew chief and 12 earned promotion to master sergeant; and

WHEREAS, In February 2004, Sergeant Stiefvater became an A-10 13 14 Thunderbolt and B-52 tactical aircraft superintendent with the 10th Air Force at Naval Air Station Fort Worth Joint Reserve Base; 15 in 16 July 2010, he left active duty to work at Lockheed Martin Aeronautics in Fort Worth, but as a traditional reservist, he 17 continued to serve at Barksdale AFB as aircraft maintenance 18 superintendent for the 717th Aircraft Maintenance Squadron and then 19 20 as superintendent of the 307th Maintenance Group; during this time, 21 he also volunteered for a detail at Dyess AFB in Abilene; he was promoted to chief master sergeant in July 2012; and 22

23 WHEREAS, In all his endeavors, Sergeant Stiefvater enjoys the 24 love and support of his wife, Teresa Kathleen Stiefvater, and his
